Dedication

Knew all men by these presents; That we W. V. Rinehart and Amanda S. Rinehart his wife, J. W. Hunt and Mary H. Hunt his wife and D. H. Salmer - all of King County Washington Territory, have this 20th day of March A.D. 1889, laid off and plotted as a town plat to be known as Commercial Street Steam Motor Addition to the City of Seattle - that certain tract of land lying in the E. B. McCallister Donation Claim No. 39 in Sections 19 & 20 in Township 24 North of Range 4 East in King County Washington Territory, of which we are the owners; bounded and described as follows to wit: Beginning at a point on the East line of the E. B. McCallister Donation Claim in Sec. 20, T. 24 N. R. 4 E. W. 1/4 which point is 24.25 chains South of the N.E. corner of said Donation Claim. Thence N. 56° W. 8.25 chains, thence North 1.25 chains to the N.W. corner of land belonging to Dr. Phillips; thence North 1.25 chains; thence East 1.25 chains to an intersection with the East line of Bishop Street in extension of said street in McCallister Addition; thence North along the extension of said East line of Bishop Street 4.25 chains. Thence East to the East line of the Donation Claim; thence North along the extension of said East line of Bishop Street where the North line of Broadway Street, as laid in the plat of McCallister Addition intersects the East line of the Donation Claim. Thence West along the South line of Blocks 5, 6, 7 & 8, of McCallister Addition to a point on the East line of McCallister Addition at the South East corner of Block 2 in said Addition which point is 32.25 chains East of and 7.25 chains South of the N.W. corner of the E. B. McCallister Donation Claim; thence South along the East line of the McCallister Addition 8.25 chains to the S.E. corner of said Addition; thence West along the South line of said McCallister tract 20.25 chains to the S.W. corner of said McCallister tract; thence along the West boundary of said tract N. 20° W. 8.25 chains to the S.E. corner of a tract of land conveyed by E. B. McCallister & wife to Geo. H. Smith Jr.; thence West along the South line of said tract 4.25 chains to the West line of the E. B. McCallister Donation Claim. Thence South along said West line of claim 20.25 chains to the S.W. corner of the Claim; thence East along the South Boundary of the Claim 20.25 chains to the fractional corner of the claim; thence North 5.25 chains; thence East 12.25 chains to a point which is distant 444 feet at right angles from a line in extension of the first course of this description; thence S. 56° E. parallel with said first course and 444 feet distant from it 13.25 chains to the East line of the Donation Claim. Thence North along said East line of Claim 8.25 chains to the place of beginning. The streets and alleys in said plat (the same accompanying and being part of this instrument) are hereby dedicated to the use of the public.
