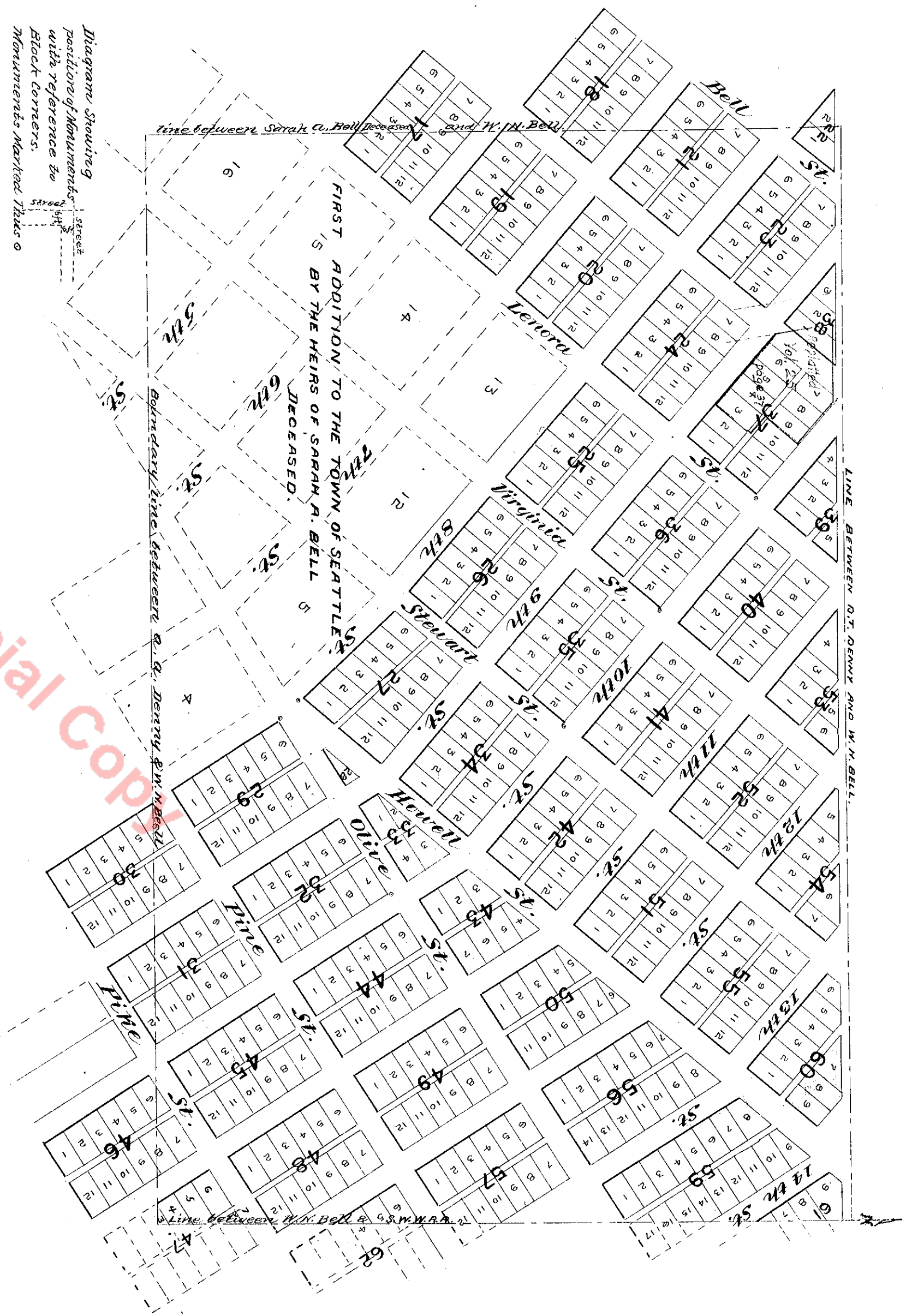


Plat of the Second Addition to the
TOWN OF SEATTLE
as laid off by the Heirs of Sarah A. Bell (Deceased)



This Addition is a portion of the Donation Claims of William N. Bell and A. D. Denny in Township 25 North of Range 4 East, all except fractional lots are 60 ft. by 120 ft. Streets 60 ft wide Alleys 16 ft wide. The Streets North Stewart & Howell which so run as to connect the intersections of the center lines of Stewart & Olive Sts with the center line of 8th St North and South of said Sts. The Streets South of and including Olive St. correspond in direction with the Streets in Arthur A. Denny's Platitions.

There are the following monuments consisting of a copper tack centered plugs driven flush with the ground placed in this Tract which are hereby made a part of the Record but; at the points of intersection of a line 6 ft. West of and parallel to the Eastern margin of Eight St with lines 6 ft. South of and parallel to the Northern margins of Lenora, Virginia, Stewart & Howell Streets and with the lines 6 ft. North of and parallel to the Southern margins of Stewart & Olive and with the division line between the Donation Claims of W. N. Bell & A. D. Denny. Also at the points of intersections of a line 6 ft. East of and parallel to the western margin of 10th Street with lines 6 ft. South of and parallel to the Northern margins of Lenora, Virginia, & Stewart Sts. and with a line 6 ft. North of and parallel to the Southern margin of Olive St. and with the division line between the Donation Claims of W. N. Bell and A. D. Denny as is more fully set forth in the accompanying Maps.

Now all men by these presents, That the within described Addition is a portion of the Donation Claims of William N. Bell, and A. D. Denny in Township 25 North of Range 4 East and lies adjoining to and east and north of the Addition to the town of Seattle as previously laid off by the Heirs of Sarah A. Bell "deceased" and the proprietors have laid out the same in accordance with the within plat, and hereby donate the Streets and alleys as designated therein to the Public use, witness our hands and seals this 13th day of December A. D. 1875
