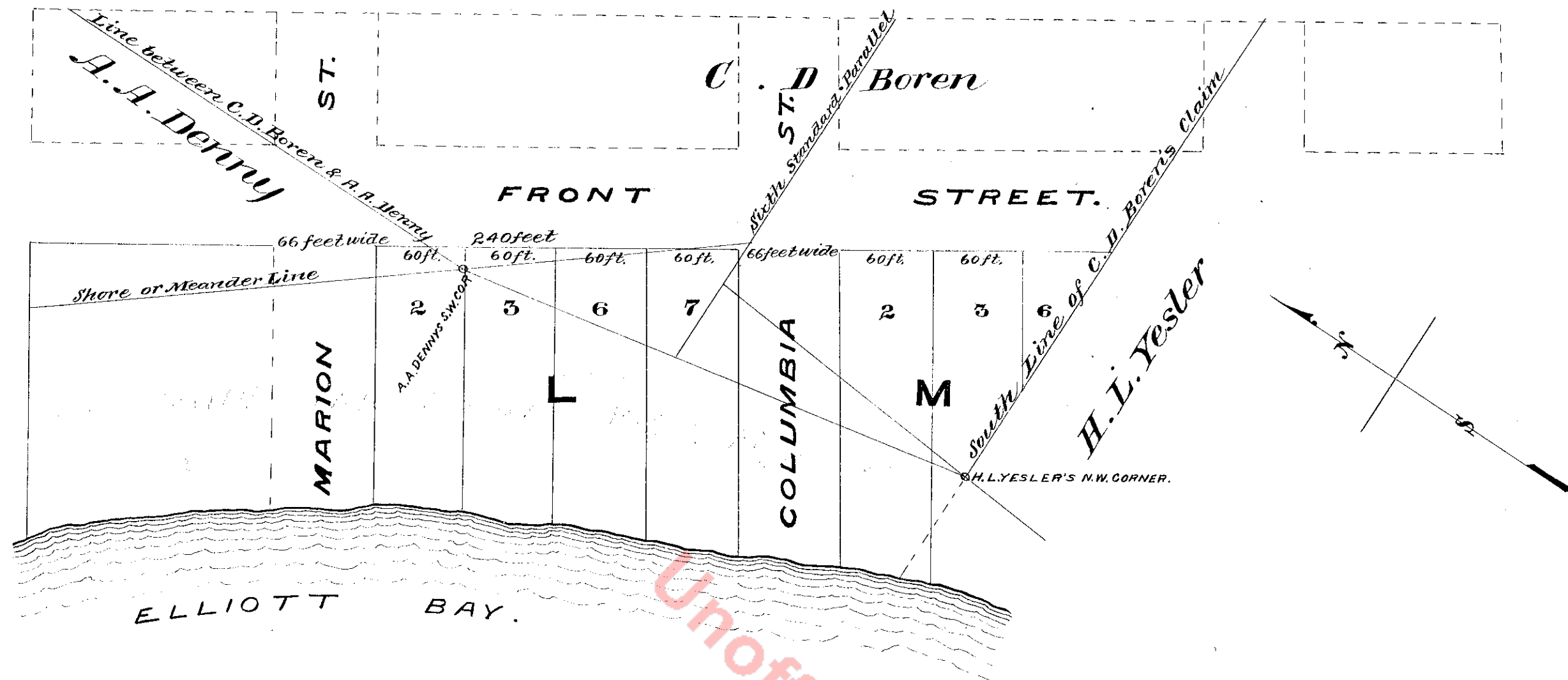


TERRY'S THIRD ADDITION

TO THE CITY OF SEATTLE.

Explanation. The above designated Town plat is situated in part of Section 6 of Township 24 North, Range 4 East and in part of Section 31 of Township 25 North Range 4 East of the Willamette Meridian, and embraces that area bounded by Marion Street, Front Street, the South line of C. D. Boren's Claim and Elliott Bay. The Streets correspond in position to the Streets similarly named and noted on the plat of the Town of Seattle as laid out on the Claims of C. D. Boren and A. A. Denny and recorded in the Office of the Auditor of King County, Washington Territory in Plat Book No. 1, page 27.

Now all men by these presents, That Franklin Matthias and Erasmus M. Smithers, Executors and Trustees of the Estate of Charles C. Terry deceased, and also the Seattle and Walla Walla Rail Road and Transportation Company, a corporation duly organized under the laws of the Territory of Washington, do hereby declare, that the above designated Town Plat, together with the Explanation appended thereto is the Map of Terry's Third Addition to the City of Seattle and that the Streets embraced within and adjoining the said Town Plat are hereby donated to and dedicated for the use of the public, in witness whereof the said Executors and Trustees have hereunto affixed their hands and seals and the said Seattle and Walla Walla Rail Road and Transportation Company has caused to be hereunto affixed its Corporate seal and the President of the said Company, by virtue of Authority vested in him has hereunto affixed his signature and the Secretary of the said Company has duly attested the Execution hereof this sixteenth day of February A. D. 1876.
