

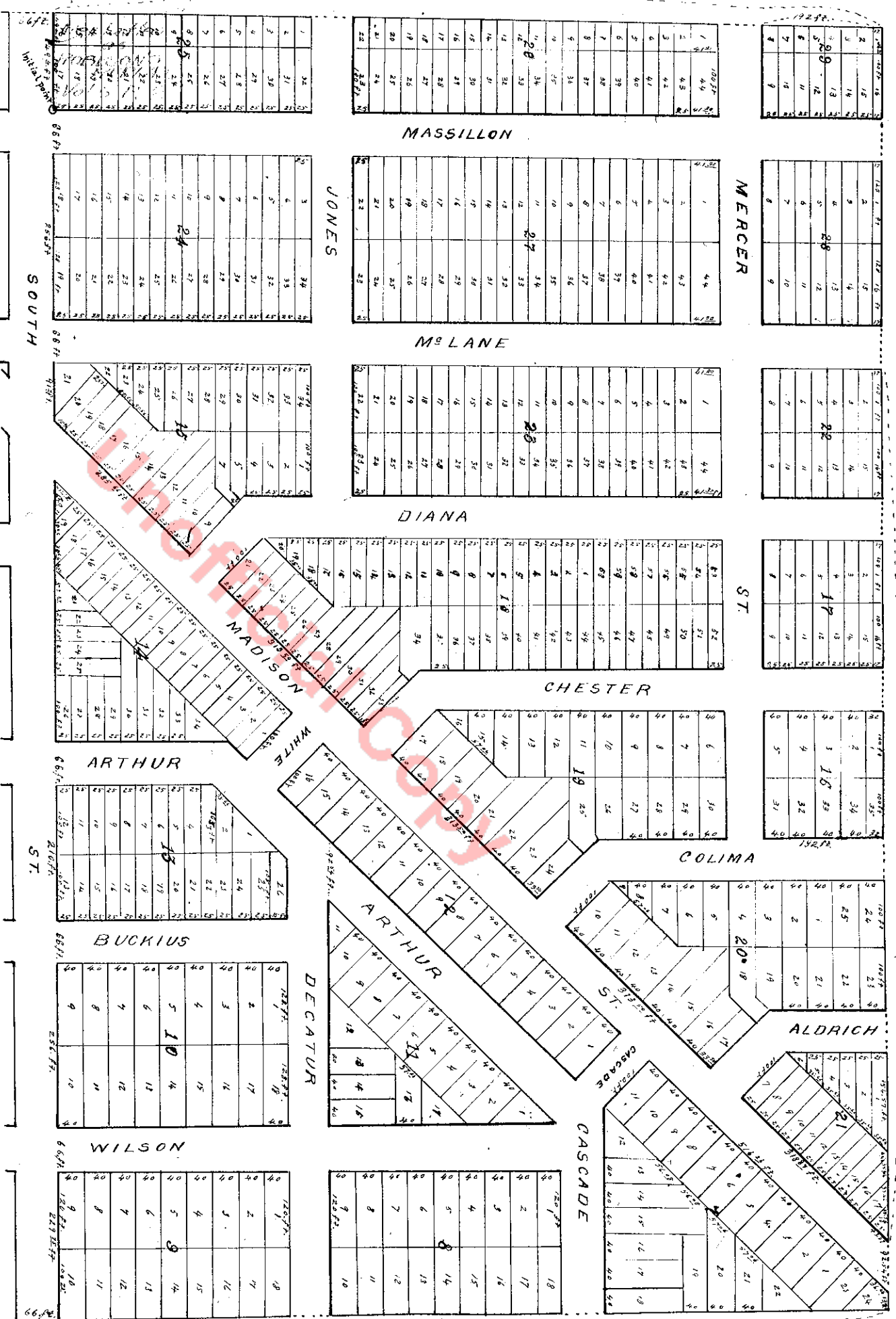
MADISON STREET CITY ADDITION TO THE CITY OF SEATTLE

~ Description ~

This Madison Street Addition to the City of Seattle embraces all the NW 1/4 of the SE 1/4 and the NW 1/4 of the NE 1/4 of the sec 28 Tp. 25 North Range 4 East WM. The initial point of this plat is the SE corner of Block 25 which said point is 1358 ft North of and 1494 ft East of the 1/4 sec corner between secs 28 and 33 said Tp 25 of Range 4 East WM.

All streets are 66 feet wide each
Massillon, M.Lane, Arthur, Buckius and Wilson are continuations of streets of same name in other plats.

The angle of Intersection of Madison St is 45°30'

Regular lots in Blocks 13, 14, 15, 17, 18, 21, 22, 23, 24, 25, 26, 27, 28, 29 are 25 feet wide fractional ones excepted, All lots except fractional in other Blocks are 40 feet wide
