DESCRIPTION

This Maple Leaf Addition to Green Lake Circle is laid off as shown on the annexed plat and occupies all of the East 1/2 of Sec. 32, the W 1/2, and the S 1/2 of the S.E. 1/4 of Sec. 33, in T.26 N. R. 4 E. The Initial Point is the S.W. corner of tract numbered 5 which is 20 feet Nor. of and 20 feet East of the Sec. Cor. to Sections 4 & 5, 32 & 33 T. 26 N. R. 4 E. Ming Co. W.T. Streets are 40 feet wide marginal Streets are 20 feet wide. The blocks are 620 feet by 290 feet. The lots in acres 1 & 5 are 48 1/2 feet by 112 feet. The lots in acres 2, 3 & 4 are 44 feet by 143 feet.
