


CHILBERG'S ADDITION

This Chilberg's Addition to West Seattle embraces all the following described tract, lot and parcel of land, situate, lying and being in the County of King, Territory of Washington and particularly bounded and described as follows to-wit: All of Lot number two (2) and the North West quarter (N.W. 1/4) of the South East quarter (S.E. 1/4) of Section number fifteen (15) in Township number Twenty four (24) North of Range number Three (3) East of Willamette Meridian, containing 50 acres more or less.

The Initial point of this plat is the North East Corner of Block number seven (7) which is thirty (30) feet South and thirty (30) feet West from the North East corner of this tract.

All angles size of lots and widths of Streets and avenues are as indicated on the face of the plat herewith.

Know all Men by these Presents, that we Nelson Chilberg and Matilda C. Chilberg his wife owners in fee simple of the land above described hereby declare this plat of 'CHILBERG'S ADDITION TO WEST SEATTLE' and hereby dedicate to the use of the public forever all the streets and avenues as shown here on.
