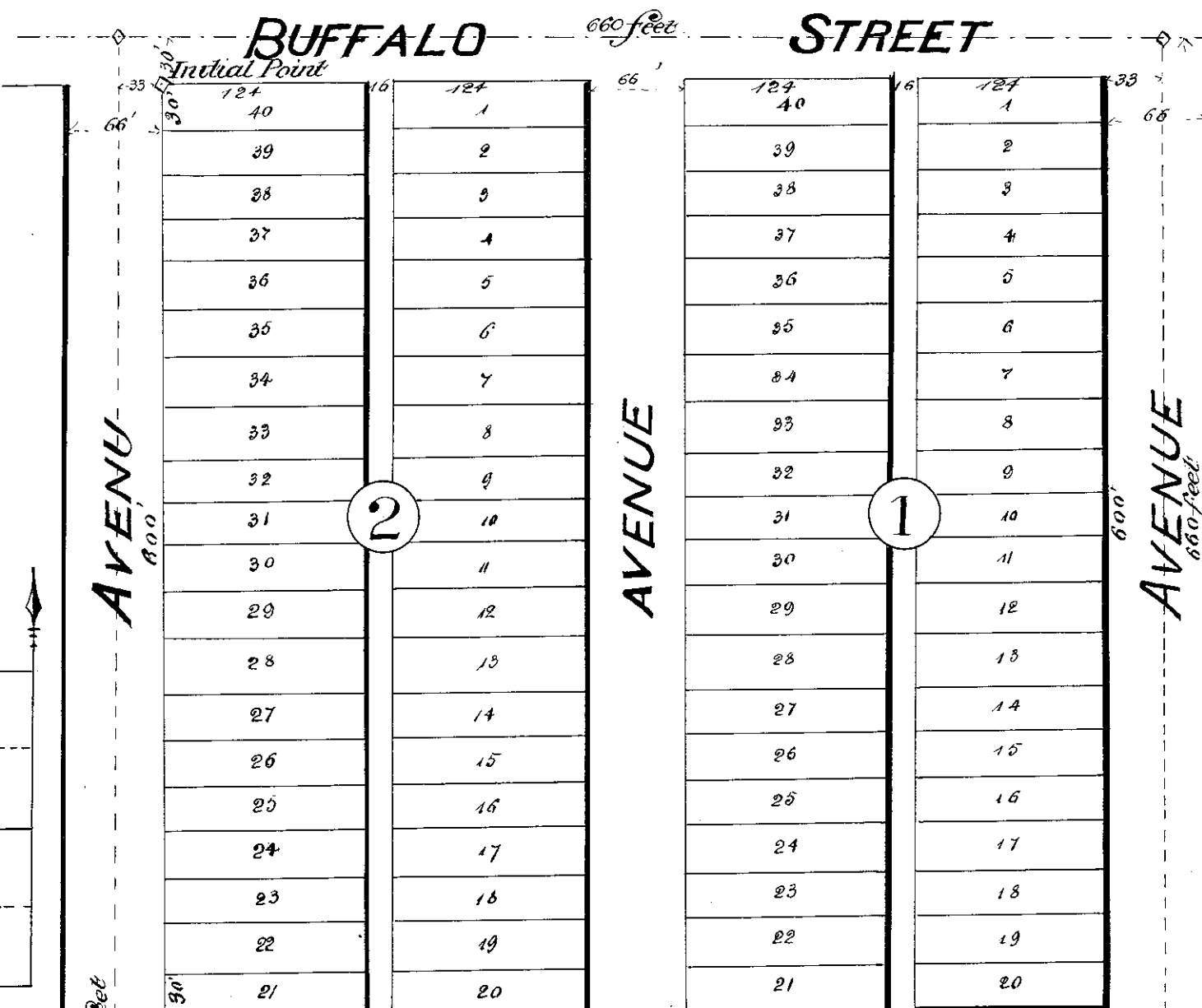
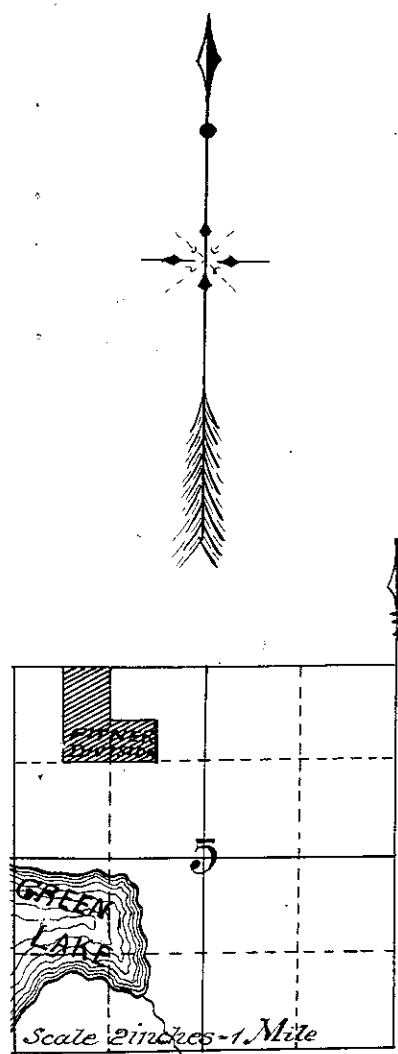

Explanation.

This Pitner's Division of Green Lake Addition to Seattle W.T. embraces all of the E. 1/2 of the N.W. 1/4 of the N.W. 1/4 and the S.W. 1/4 of the N.E. 1/4 of the N.W. 1/4 of Section Five (5) in T. 25 N. R. 4 E. W.M. King County Washington Territory containing Thirty (30) Acres more or less. The Initial Point of this plat is the N.W. corner of lot Forty (40) in Block Two (2) which is 700 feet East and 50 feet South of the N.W. corner of Section Five (5) in T. 25 N. R. 4 E. W.M. Size of lots and width of streets, Avenues, and Alleys are as marked on the face of the plat in feet.
