Description

The INITIAL POINT of this plat is the U.S. GOVERNMENT SURVEYS $\frac{1}{4}$ post between Sections 10 and 11 in Twp. 24 N. Range 3 E. W.M. From thence EAST, 1324.3 ft. - Thence NORTH, 2773.5 ft. to the Southern line of Section 2 of said Township. - Thence WEST along the line between said Sections 2 and 11, a distance of 260 ft. to the shore. - Thence along the meanders of said shore, S. 33° W. 418.4 ft. - Thence S. 33° 30' W. 1056 ft. - Thence S. 28° 30' W. 462 ft. - Thence S. 47° W. 1295.25 ft. - Thence S. 37° 57' E. 485.1 ft. - Thence EAST 660 ft. to the Section line between said Sections 10 and 11. - Thence NORTH along said Section line 233.64 ft. to the place of beginning.
The S.E. cor. of lot 4 block 13 is 1324.3 ft. EAST of said $\frac{1}{4}$ post.
Streets and Avenues are of widths shown on the plat. - Alleys are 20 ft. wide.
Lots are 25 x 100 feet, or as indicated on the plat.

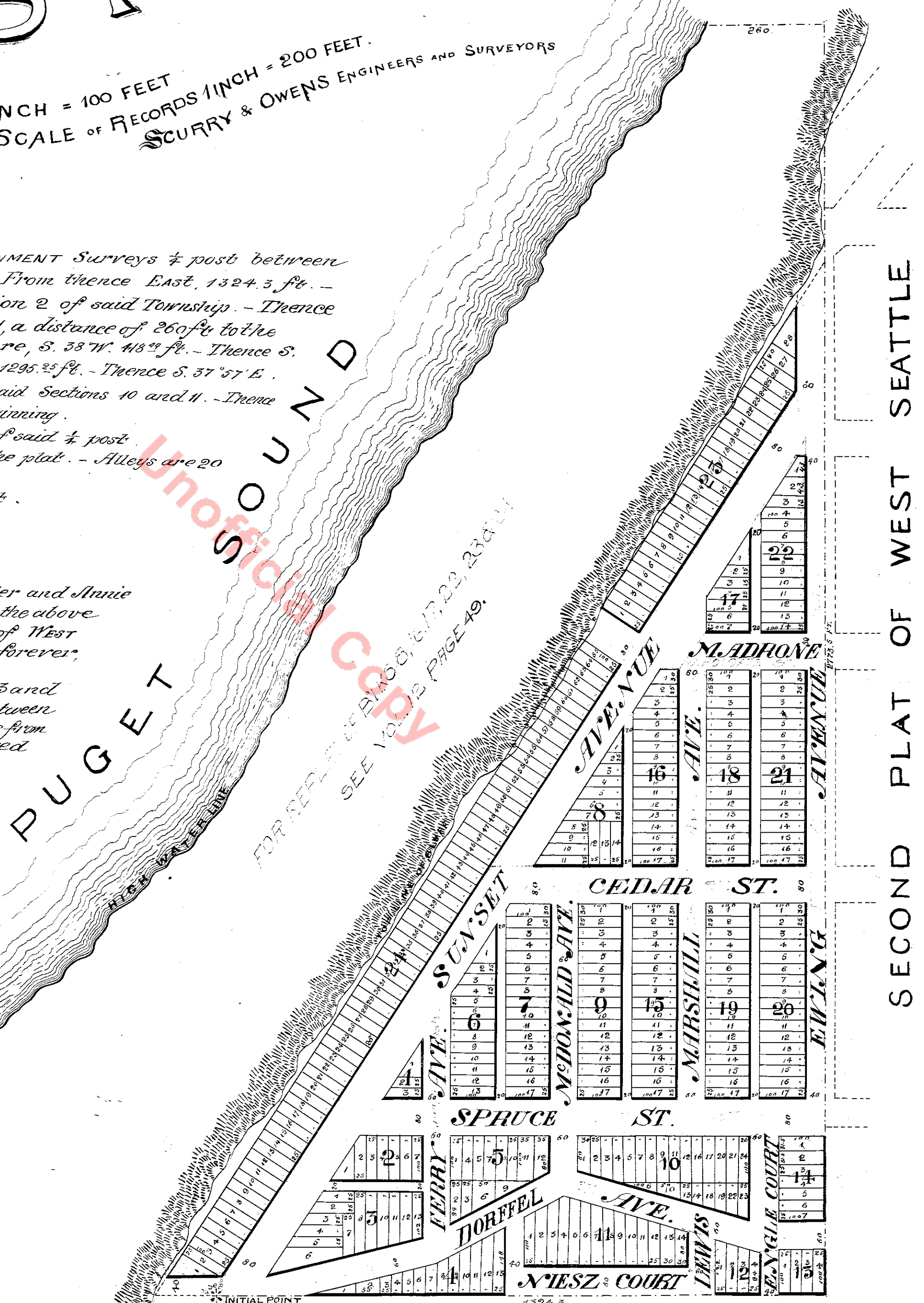
Dedication
