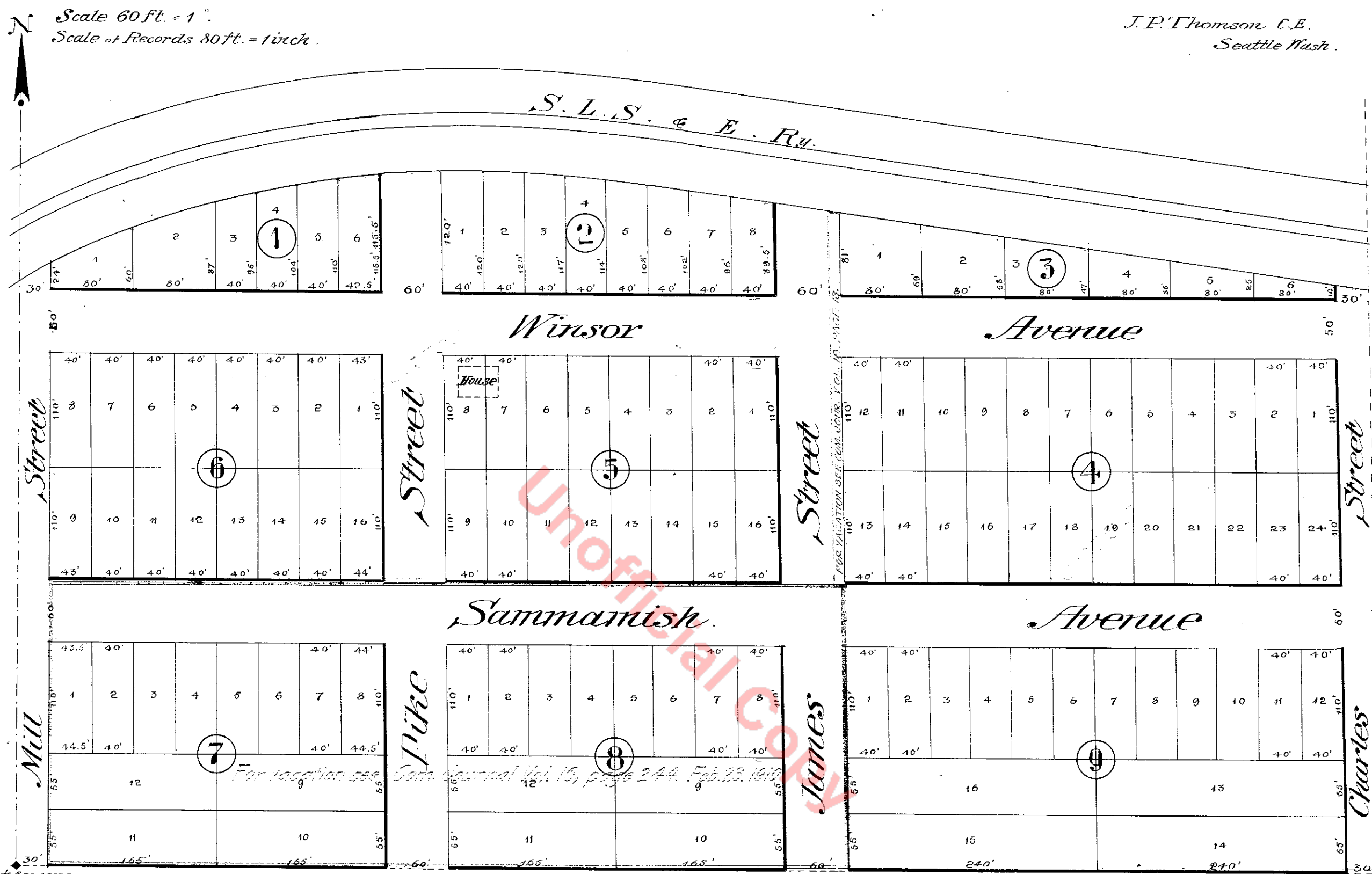


# Plat of the WINSOR Townsite King Co. Wash.

### DESCRIPTION.

This plat of the Town of Winsor covers the south  $\frac{1}{2}$  of the south-west  $\frac{1}{4}$  of the north-west  $\frac{1}{4}$  of sec 8 Tp 26 N. R. 5 E., except that portion of said  $\frac{1}{2}$  of S.W.  $\frac{1}{4}$  of N.W.  $\frac{1}{4}$  of said sec. 8 covered by the Right of way of the S.L.S. & E. Railroad Co.

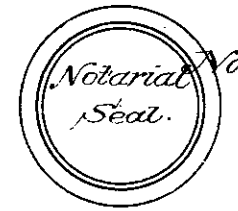
