Map of

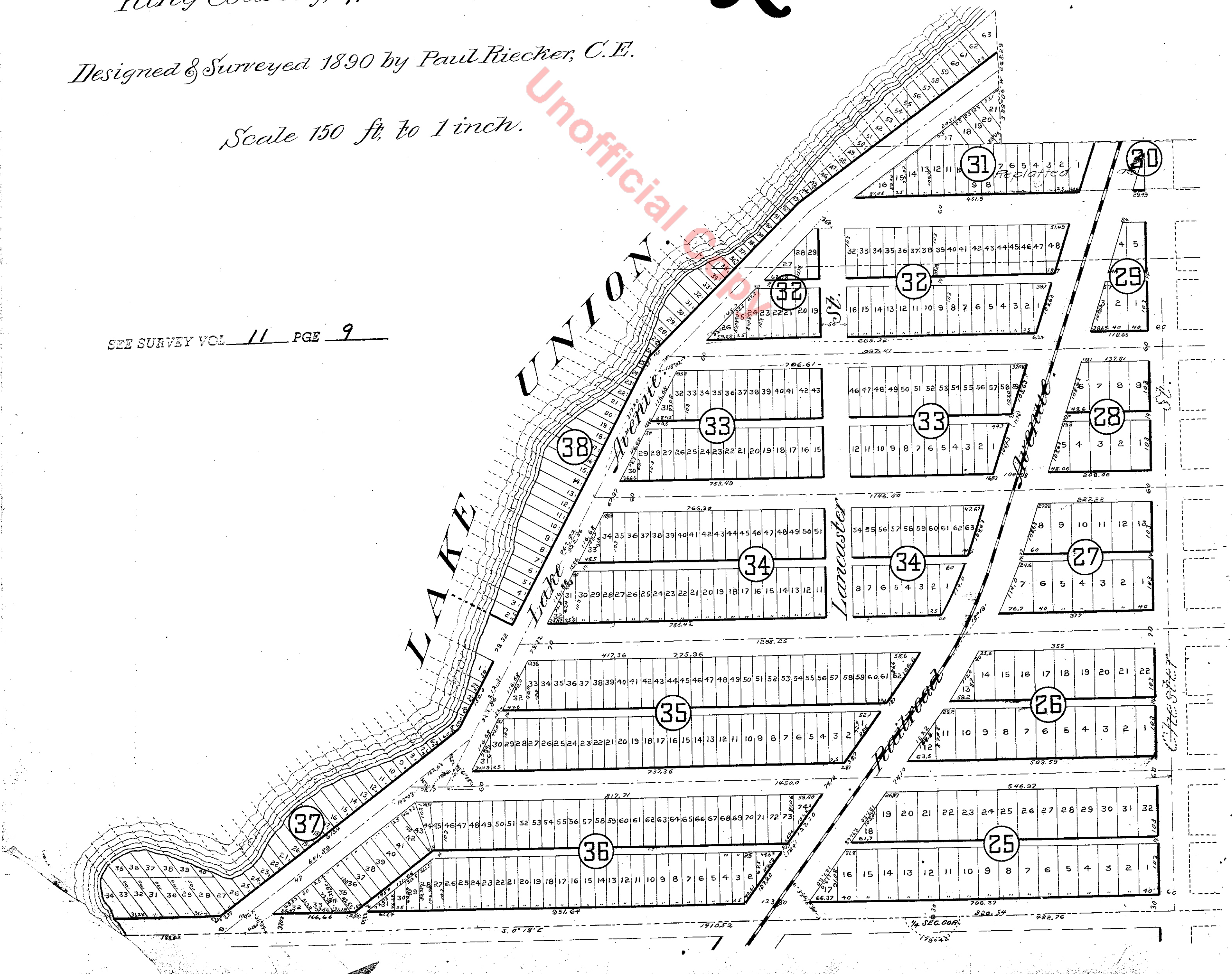

Description.

This Brooklyn Addition to Seattle embraces all of the following described tract of land in Sec 17, Twp 25, N, R. 4, E. Beginning at the corner to Secs 8, 9, 16 and 17, T. 25, N. R. 4, E. running thence south 89°33' West along the North line of Sec 17, 1546.62 ft. thence south with a line parallel to the East boundary line of Sec 17, 2449.53 ft. thence turning to the south west with an angle of 89°06' and running 268.29 ft. to the Shore of Lake Union, thence following the Shore of Lake Union in a South Easterly direction to the East line of Sec 17, thence North along the East line of Sec 17 to the point of beginning.

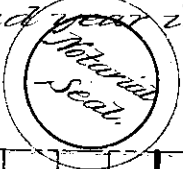

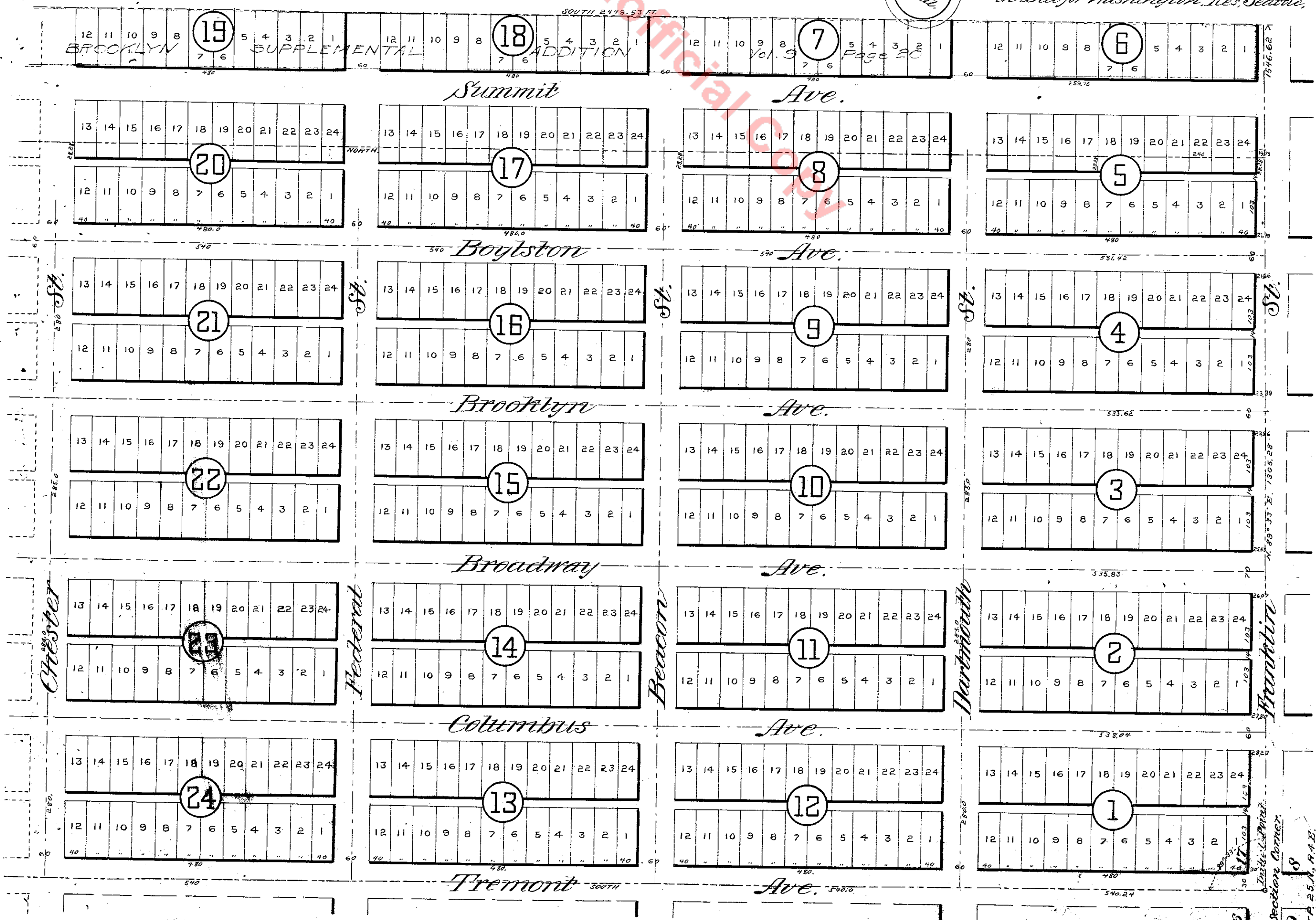
