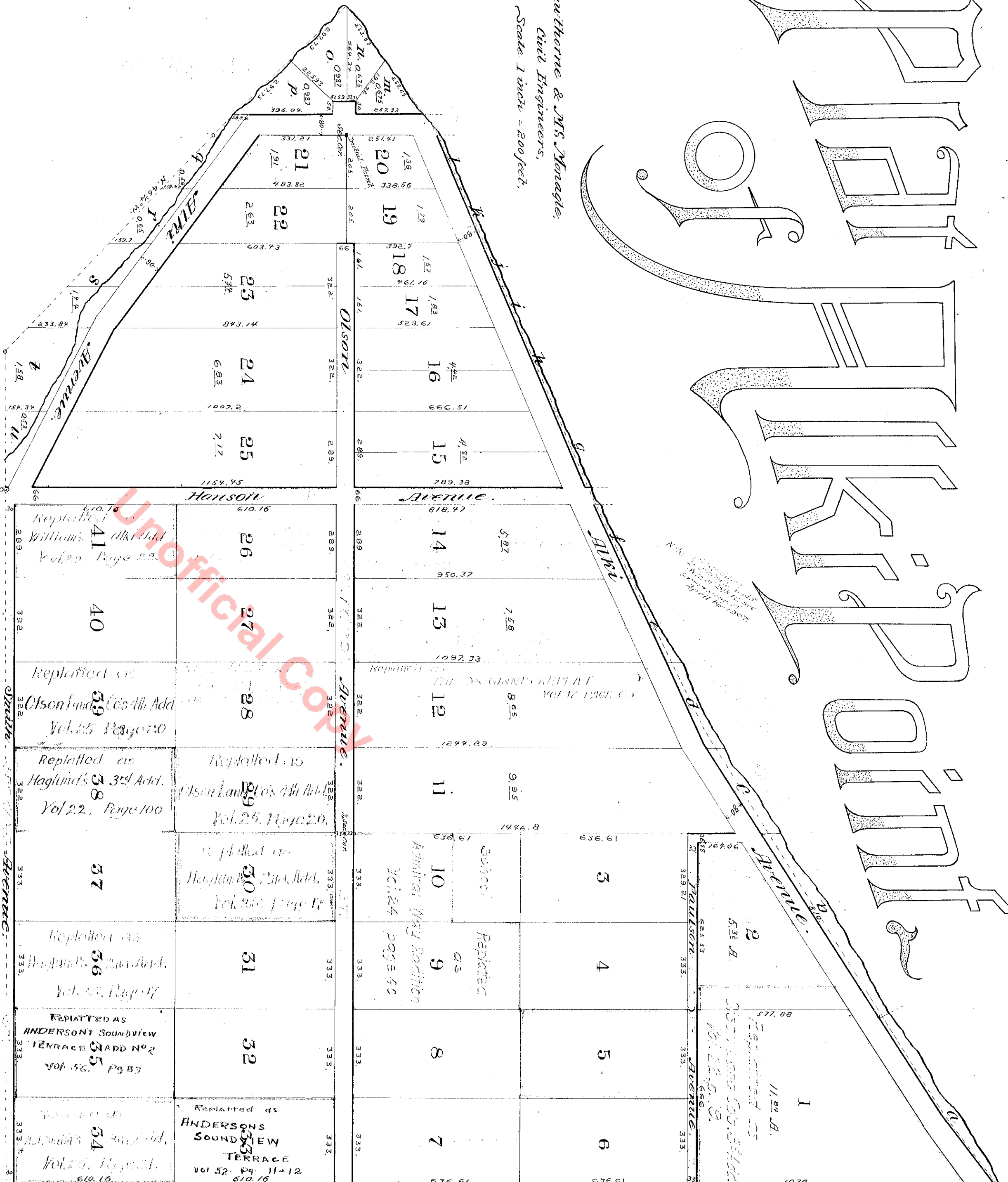


Part of Alki Point

Explanation.

The initial front to the section cover by sections 9, 10, 15 & 10 Twp 24 N, Range 3 E, W. Tl. Distances are marked in feet on the plat. Areas are given in acres.

Description.

This plat of Alki Point embraces all of Government Lot No. 1 of sect. 16. The N. W. 1/4 and the N.E. 1/4 of the S.W. 1/4, and the N.W. 1/4 of N.E. 1/4 of sect. 15. - Quit Lots Nos. 2, 3 & 4 and the S.W. 1/4 of the S.E. 1/4 of Sect. 10 and Quit Lot No. 1 of sect. 9, all being in Township 24 N Range 3 E, W. Tl.

Dedication.

From all men by these presents, that we Hans, W. Hanson and Anna Hanson, his wife and Trustee, Olson, unmarried, owners in fee simple of the above described property hereby declare this plat as the plat of Alki Point, and hereby dedicate to the use of the public, be forever all the streets and avenues platted thereon, subject however to the following conditions, reservations and exceptions. Whenever on any part of the area covered by this plat, any riparian right has heretofore been or but for this plat, would hereafter be existing or enjoyable, then notwithstanding this plat it shall be existing and enjoyable, but only according to and limited by the boundary lines of lots as platted in this plat, which boundary lines shall be deemed lines of subdivision of areas, of possession, user and enjoyment of all riparian rights. We and our heirs and assigns forever shall notwithstanding this dedication, have the exclusive right and power within said streets and avenues to place, construct, equip, operate, control, use, repair and remove, whether above upon or under the surface of soil or water, gas pipes, water pipes, electric or other wires, cords or cables, posts, street lamps and lights and all matters of railway lines and tracks with any manner of appurtenances, apparatus and appurtenances necessary or proper for the same or the operation thereof.
