

DESCRIPTION:

Denny-Blaine-Lake Park to the City of Seattle embraces all of Lot No. 4 of the fractional Sec. 27-T.25 N. R. 4 E. described as follows:- Beginning at the Meander and 1/4 Corner of the fractional Sec's. 27 and 34 T. 25 N. R. 4 E. on the shore of Lake Washington, which is a sandstone monument, thence N. 89° 58' 40" W. 1319.3 ft. along the line between said Sec's. 27 and 34 to the Southwest corner of the tract, which is a sandstone monument; thence N. 1° 07' E. 1323.88 ft. to the northwest corner of the tract, which is a sandstone monument; thence S. 89° 54' 10" E. 1181.09 ft. to the northeast corner of the tract, which is a sandstone monument on the shore of Lake Washington; thence in a Southerly direction along the shore of Lake Washington to the point of beginning.

All tracts and streets are as shown on the plat.

Bearings are referred to the City Meridian.

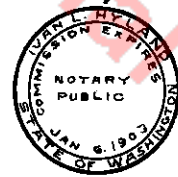
