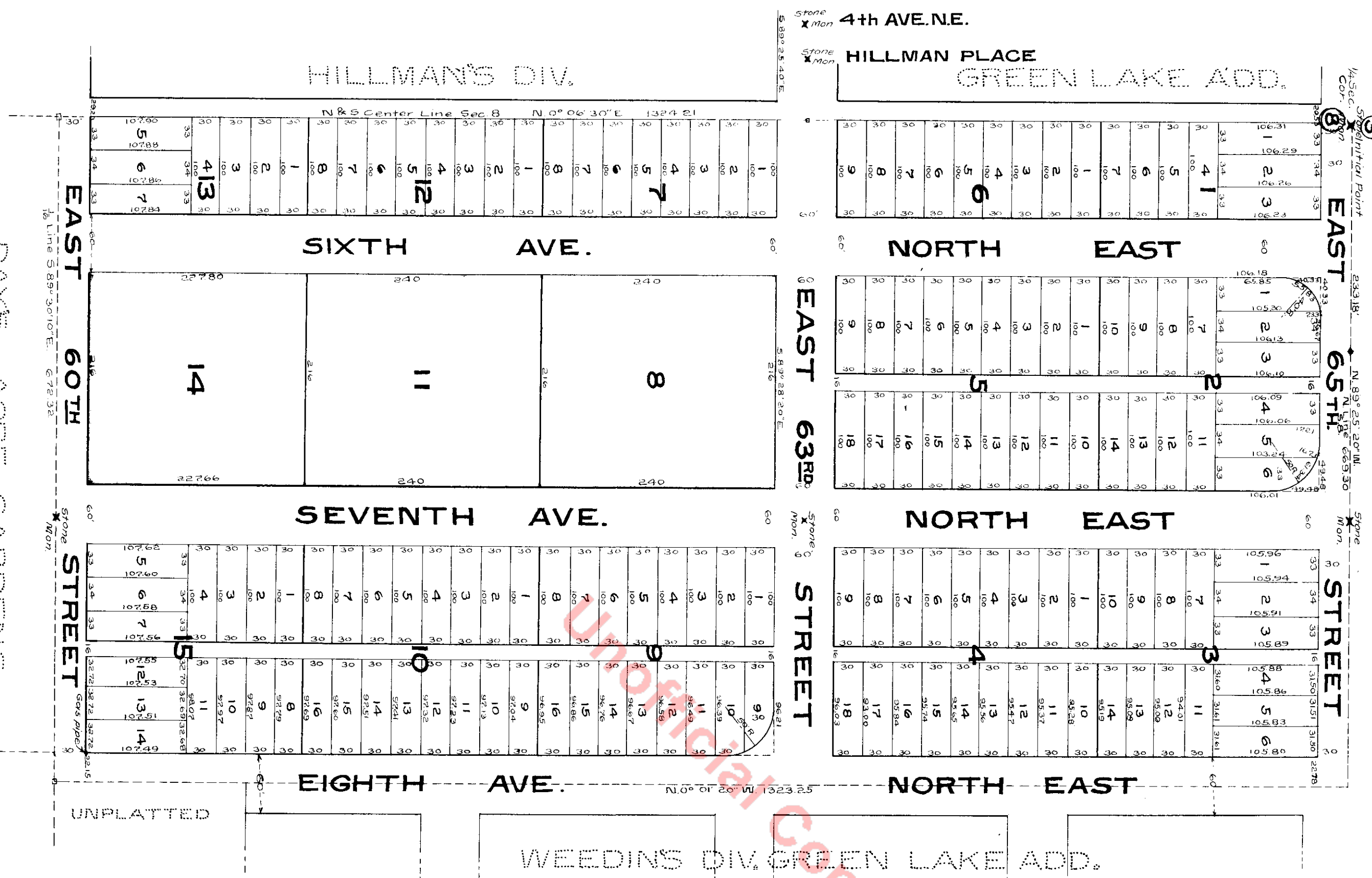


Weedins Homestead Addition

DESCRIPTION

This Plat of Weedins Homestead Addition to the City of Seattle comprises the following described tract of land: - The West Half (NW 1/2) of the North West Quarter (NW 1/4) of the North East Quarter (NE 1/4) of Section Eight (8), Township Twenty Five (25) North Range Four (4) East. The Initial Point of this Plat is the stone Monument at the North West corner of the tract. All dimensions of streets alleys and lots are as shown on the face of the Plat. All courses referred to city standard Meridian.

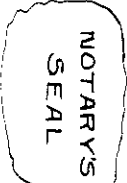

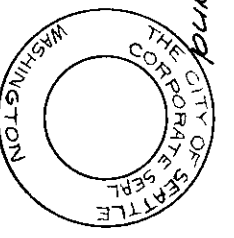
