### DESCRIPTION

This plat of INTERLAKEN, "an Addition to the City of Seattle, comprises all of the South-east quarter (SE $\frac{1}{4}$ ) of the South-west quarter (SW $\frac{1}{4}$ ) and the West half (W $\frac{1}{2}$ ) of the South-west quarter (SW $\frac{1}{4}$ ) of the South-east quarter (SE $\frac{1}{4}$ ) of Section 21 Township 25 North, of Range 4 East of the Willamette Meridian in King County, State of Washington, excepting the South-east quarter (SE $\frac{1}{4}$ ) of the South-west quarter (SW $\frac{1}{4}$ ) of the South-east quarter (SE $\frac{1}{4}$ ) of Section 21, and except those portions shown on this plat marked "Interlaken Park" and "Interlaken Parkway". The location and dimensions of all lots and blocks and the width of all streets, avenues, places, and alleys, are as shown on the face of this plat.

All courses are referred to the Standard Meridian of the City of Seattle.

The Initial Point is the  $\frac{1}{4}$  Section Corner common to Sections 21 and 28 of said Township and Range.

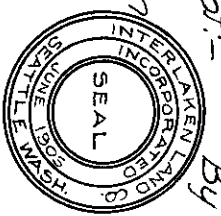
