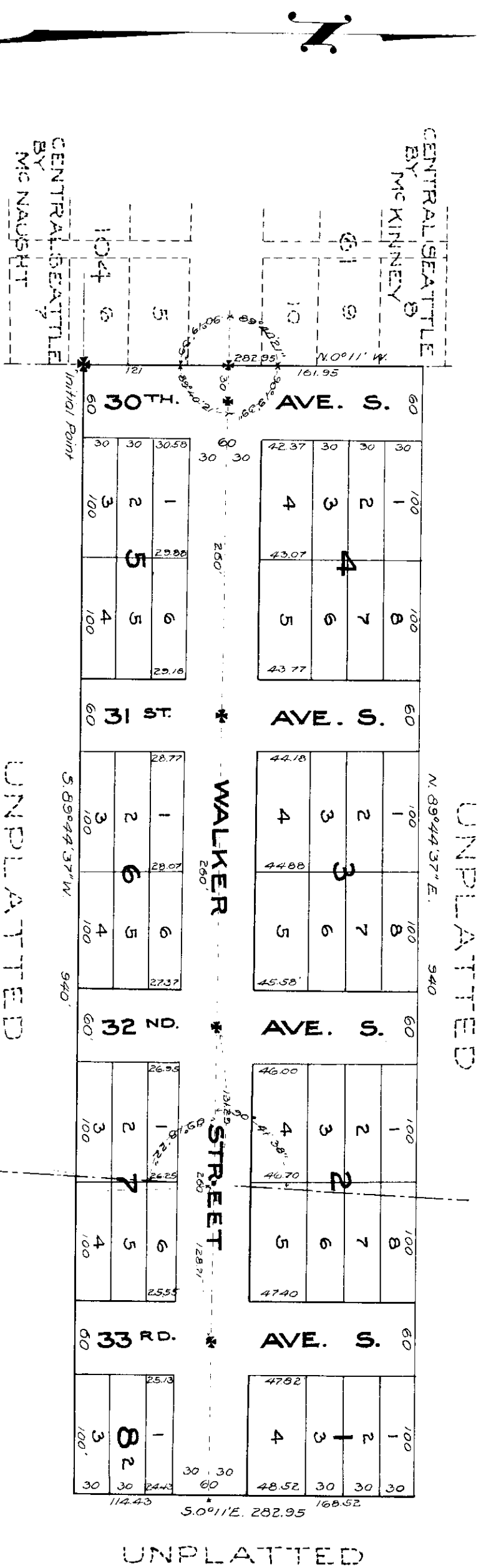


# C.P. Doses's Lote Washington Addition TO THE CITY OF SEATTLE.

### DESCRIPTION

This plot of C.P. Doses's Lote Washington, Addition to the City of Seattle, is the west 940 feet (9) and of Lot two (2), Section ten (10) Township twenty-four (24) North, Range four (4) east, and particularly described as follows: Commencing at a point on the section line between said Sections nine and ten, 285.04 feet north from the quarter section corner between said sections nine and ten, running thence west parallel with the south line of Lot three aforesaid 673.25 ft. and to the west line of said Lot three, thence north along the said west line 282.55 feet, thence east parallel with the south line of Lot three aforesaid and the south line of this tract 688.08 feet more or less to the section line aforesaid at a point 283.33 feet north of the place of beginning; thence continuing east parallel with the south line of Lot two aforesaid 973.53 feet more or less to the Government meander line of section ten aforesaid on Lote Washington, thence, along said meander line south 24° west 104.87 feet, and then south 167.54 feet more or less to a point 284.66 feet north of the south-east corner of said Lot two on the government meander line; thence west parallel with the south line of Lot two aforesaid 942.48 feet more or less to the place of beginning, containing ten and 3/10 (10.55) acres of land more or less." The initial point is the southwest corner of the above described tract. The dimensions of all lots, streets, avenues and angles are as shown on the plan of the plot. All bearings refer to the established meridian of the City of Seattle. Cedar monuments are set at points indicated thus: - X
