

Water Front

DESCRIPTION

This Joseph R. McLaughlin's Water Front Addition to the City of Seattle, covers the following described tract of land all being in Township Twenty-four-(24) North of Range Four-(4) East of the Willamette Meridian, in King County, State of Washington to-wit:-- Lot Five (5) in Section Nineteen (19); Lots Four (4) and Five (5) in Section Twenty (20); Lots Six (6) and Seven (7) in Section Twenty-one-(21); Lot One (1) and so much of Lots Two (2) and Three (3) in Section Thirty (30) as lies North of a line which runs South 85° West 58' 54" 34" 45" W according to meridian of this plat from a point on the Duwamish River indicated by a post 75 links from the river bank, said post bearing North 23° West and 5' 08" chains from the quarter post on a line between Sections 29 and 30, and running thence to a stake near the foot of the bluff set in the hollow of a large cedar tree 48 inches in diameter, said stake being 26.80 chains from the post near the river bank; thence from said stake and cedar tree in a direct line to a post set in the center of said Section 30; excepting therefrom that portion of said Lot three (3) in Section thirty (30) which lies West of Detroit Avenue, as shown upon this plat, which said Detroit Avenue, (here made 80 feet wide) includes the County Road heretofore established and existing across said Lot three (3) at a lesser width.

The dimensions and location of all lots, blocks, tracts, streets, avenues, places and alleys are as indicated upon the face of this plat. The Meridian and Base Line from which the bearing and distances of this Plat depend, is the center line of First Avenue South from the Duwamish River on the North side of the plat to South Front Street. The said center line is monumented upon the ground and is a Due South projection of First Avenue South from the plat of "Seattle Tide Lands". The North margin of Ohio Street is 40 feet from and parallel with the South line of the property as hereinbefore described, being the line S 85° W from the river bank to the post set in cedar tree. The shore line of the Duwamish River at its ordinary mean stage, is as indicated upon the plat, and the distances thereb noted on the several tract and lot lines. Said distances are not intended as limitations of said tracts and lots, but are approximate only, the said lots in all cases carrying all shore and riparian rights upon and into the waters of said river. The dotted line crossing said shore tracts and lots and also Blocks 23 and 22 indicates the location of the existing Dyke.

State monuments are located at the points shown upon the plat. The initial point is the monument marking the intersection of First Avenue South and Michigan Avenue. At the acute angle of the alley, intersection in Blocks 2, 3, 4, 5, 6, 7, 9, 10, 11, 12, 13, 14, 15 and 16 there are curving corners, each with radius of 6.81 feet and semi-lengths of 10 feet length.

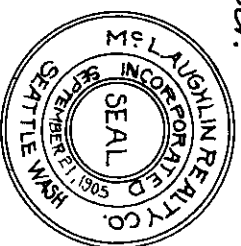
DEDICATION

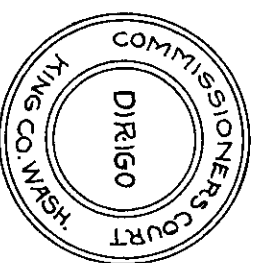

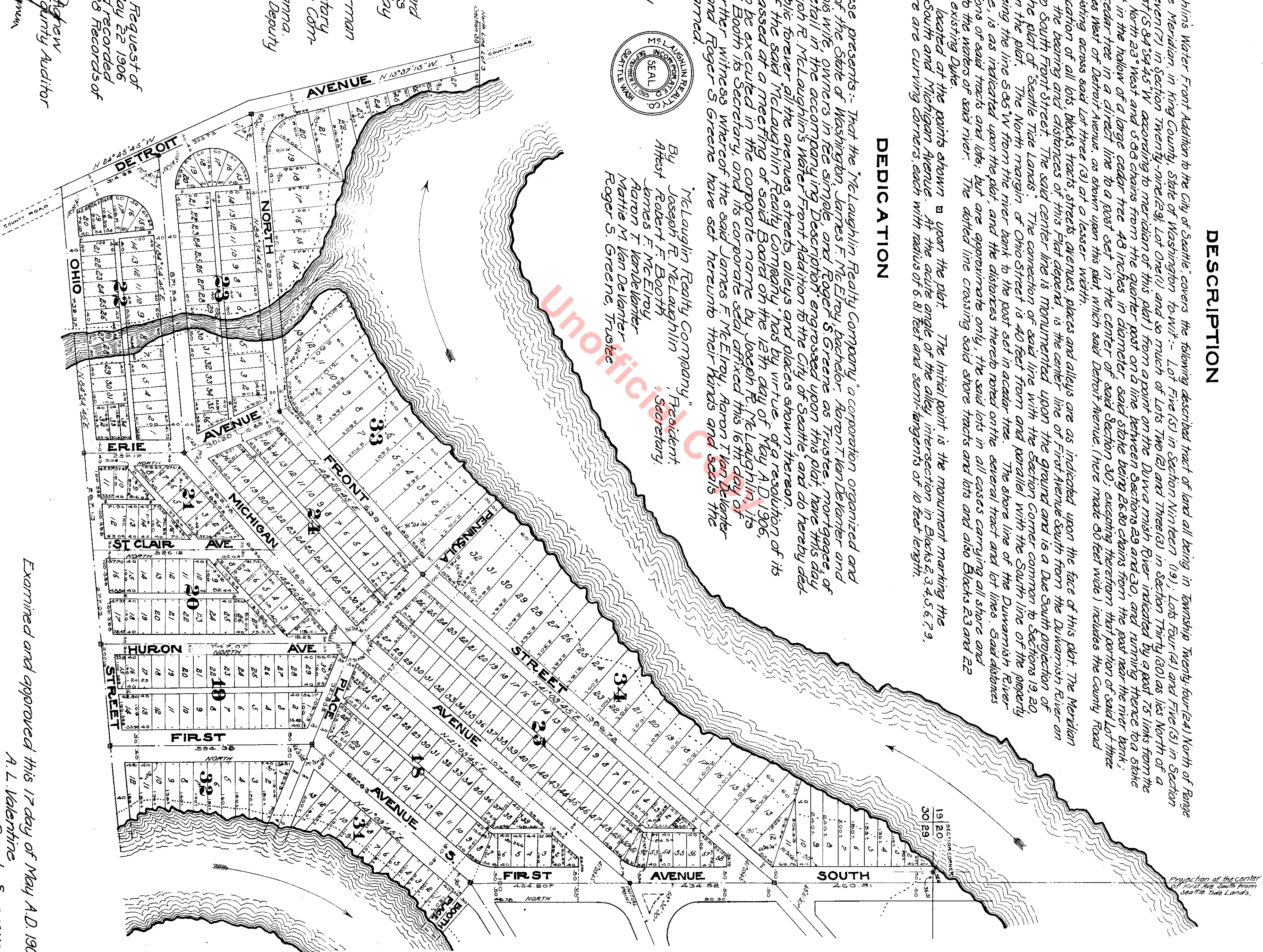

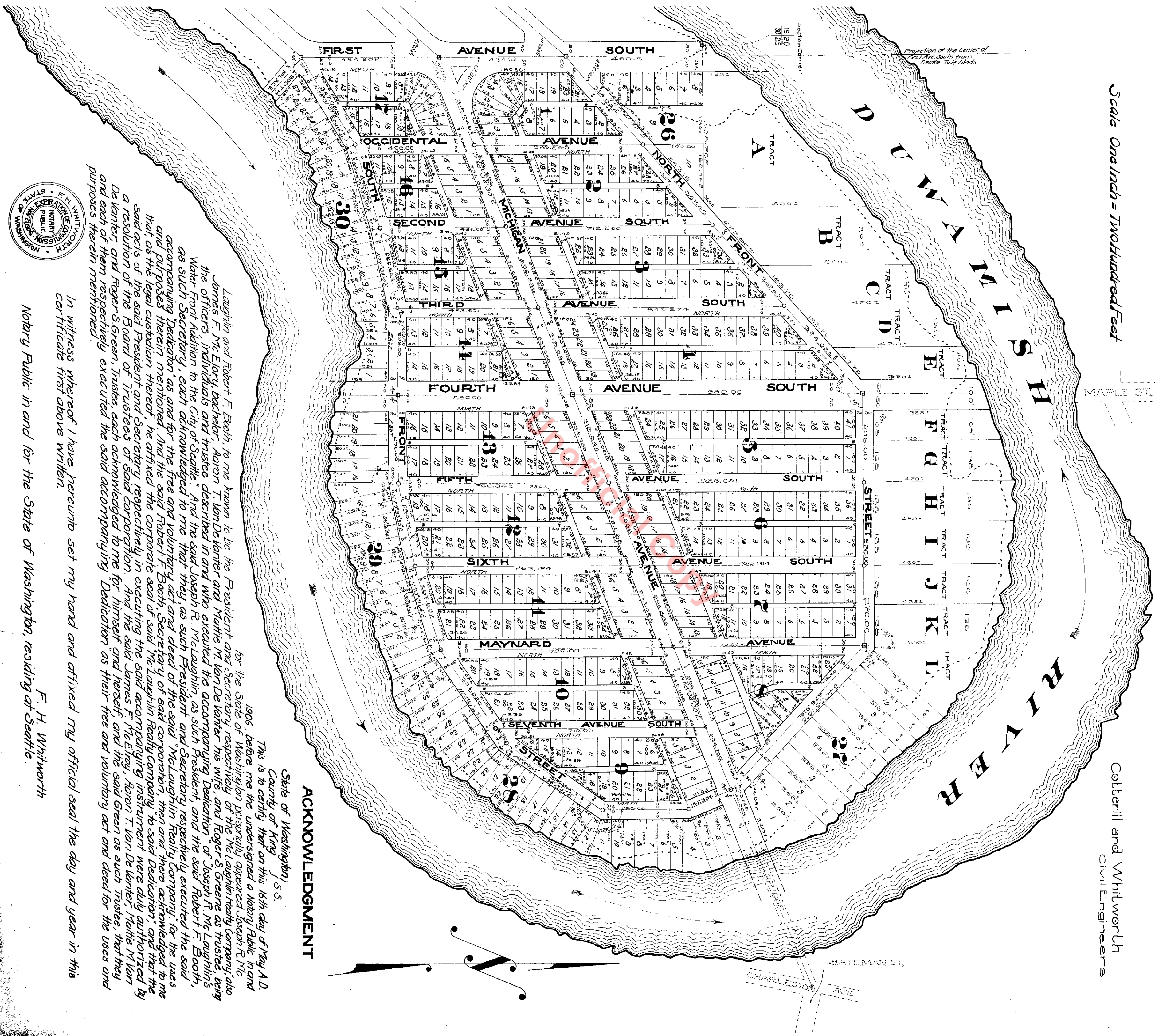
Projection of the center
