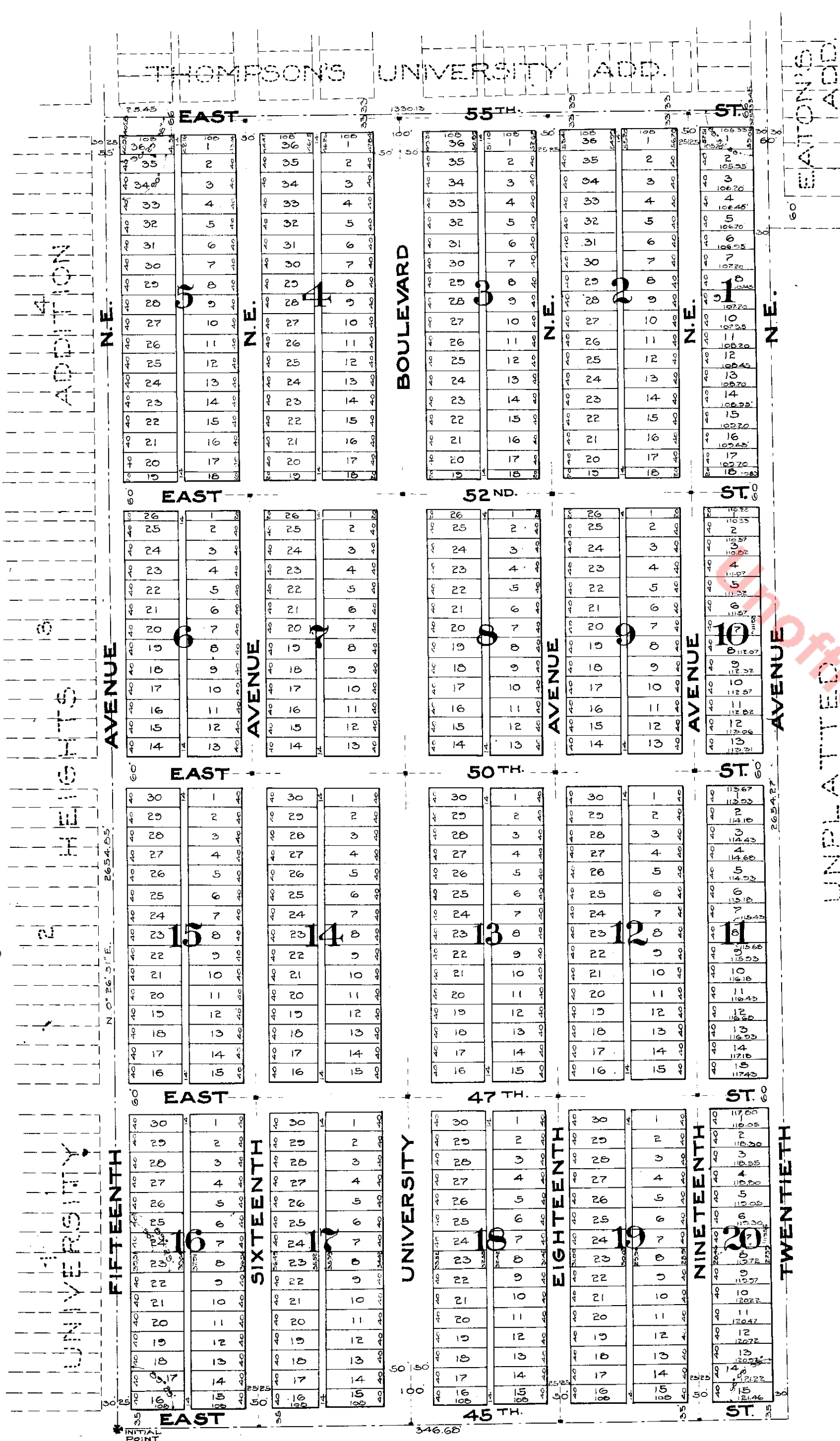

DESCRIPTION

This plat of University Park Addition to the City of Seattle, occupies the west one-half (1/2) of the south west quarter (1/4) of Section nine (9) Township twenty-five (25) North of Range four (4) east, Willamette Meridian, King County, Wash.

The width of all Avenues, Streets, Alleys, and the dimensions of all lots are as shown upon the map in text.

The initial point is the South West Corner of Section Nine (9) Township Twenty-five (25) North of Range Four (4) East, from which the South-west corner of Block Sixteen (16) is north (along the West line of this tract), thirty-five (35) feet, and east (parallel with the south line of this tract) twenty-five (25) feet.

All courses refer to the City Standard Meridian.

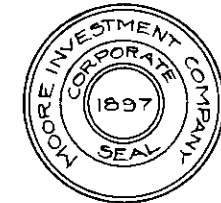
Stone Monuments are set at street intersections shown thus

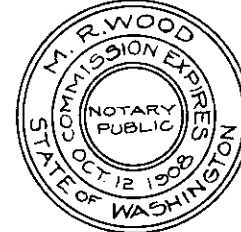
