

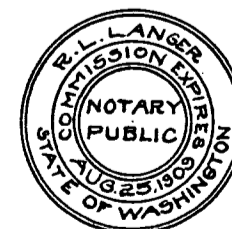
ACKNOWLEDGMENT
