

DESCRIPTION

This plat of Cascade View Addition to the City of Seattle, King County, Washington; embraces Tracts 24, 25, 28 and 31 as laid off by the State of Washington, being a portion of Section 16, Township 24 North-Range 4 East W.M. also that part of Tract 27 as laid off by the State of Washington in Section 16 aforesaid described as follows to wit: beginning at the Northeast corner of said Tract 27: thence North 88°54' West 330 ft.; thence South 00°50' West 350.35 ft.; thence South 88°35'40" East 330 ft.; thence North 00°50' East 352.12 ft. to place of beginning.

All distances are as shown on this plat in feet.

All courses are referred to the City Standard Meridian.

Stone Monuments have been set at intersection points as designated on plat.

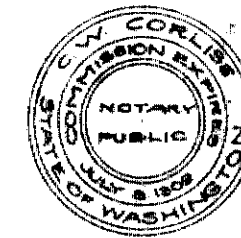
