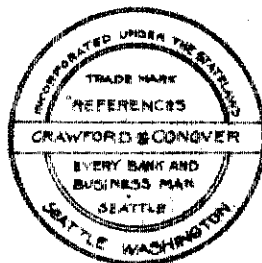

In witness whereof the said Crawford and Conover has, by virtue of a resolution of its Board of Trustees, duly passed at a meeting of said Board on the 3d day of February A.D. 1891 caused these presents to be executed in its corporate name by S.L. Crawford, its president, and Clayton Crawford, its secretary, and its corporate seal hereunto affixed this 29th day of April A.D. 1907.

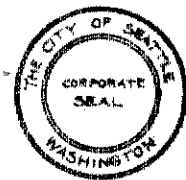

**ACKNOWLEDGMENT**

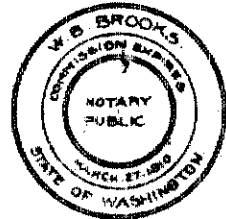

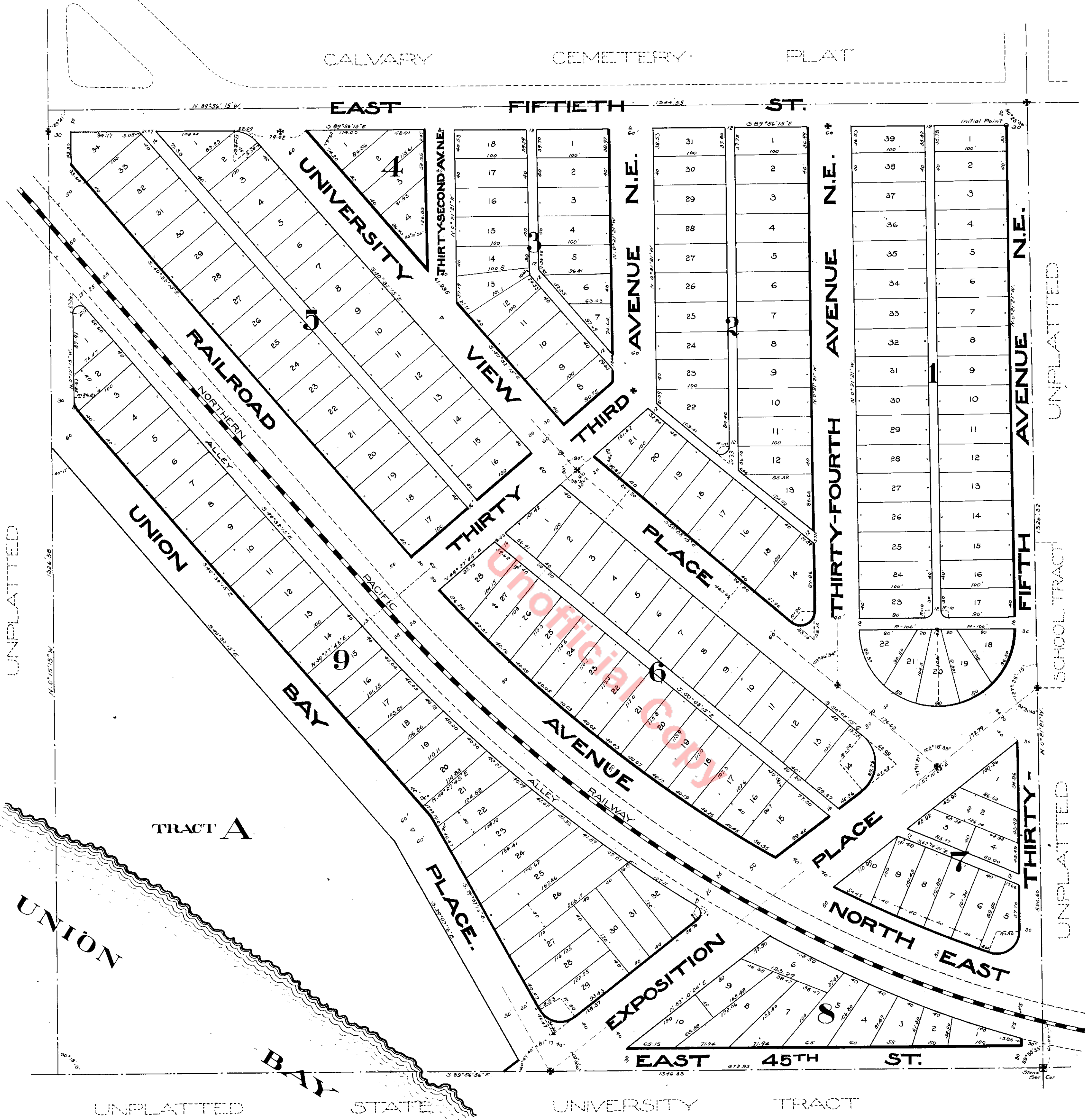

## DESCRIPTION

493176

This plat of "Exposition Heights" is an addition to the City of Seattle and covers the Southeast Quarter of the Southeast Quarter (S.E. 1/4 of S.E. 1/4) of Section Nine (9) of Township Twenty five (25) North of Range Four (4) East of the Willamette Meridian in King County, State of Washington, except that portion thereof included in the Right of Way of the Northern Pacific Railway across said tract fifty (50) feet in width.

The location and dimensions of all lots, blocks, streets, avenues, alleys and places are as indicated on the face of the plat.  
The base line of the plat is the east boundary of the tract and the avenues indicated are parallel therewith. The initial point is the Northeast corner of Block 1, which is thirty (30) feet southerly and thirty (30) feet westerly from the Northeast corner of the tract.
