

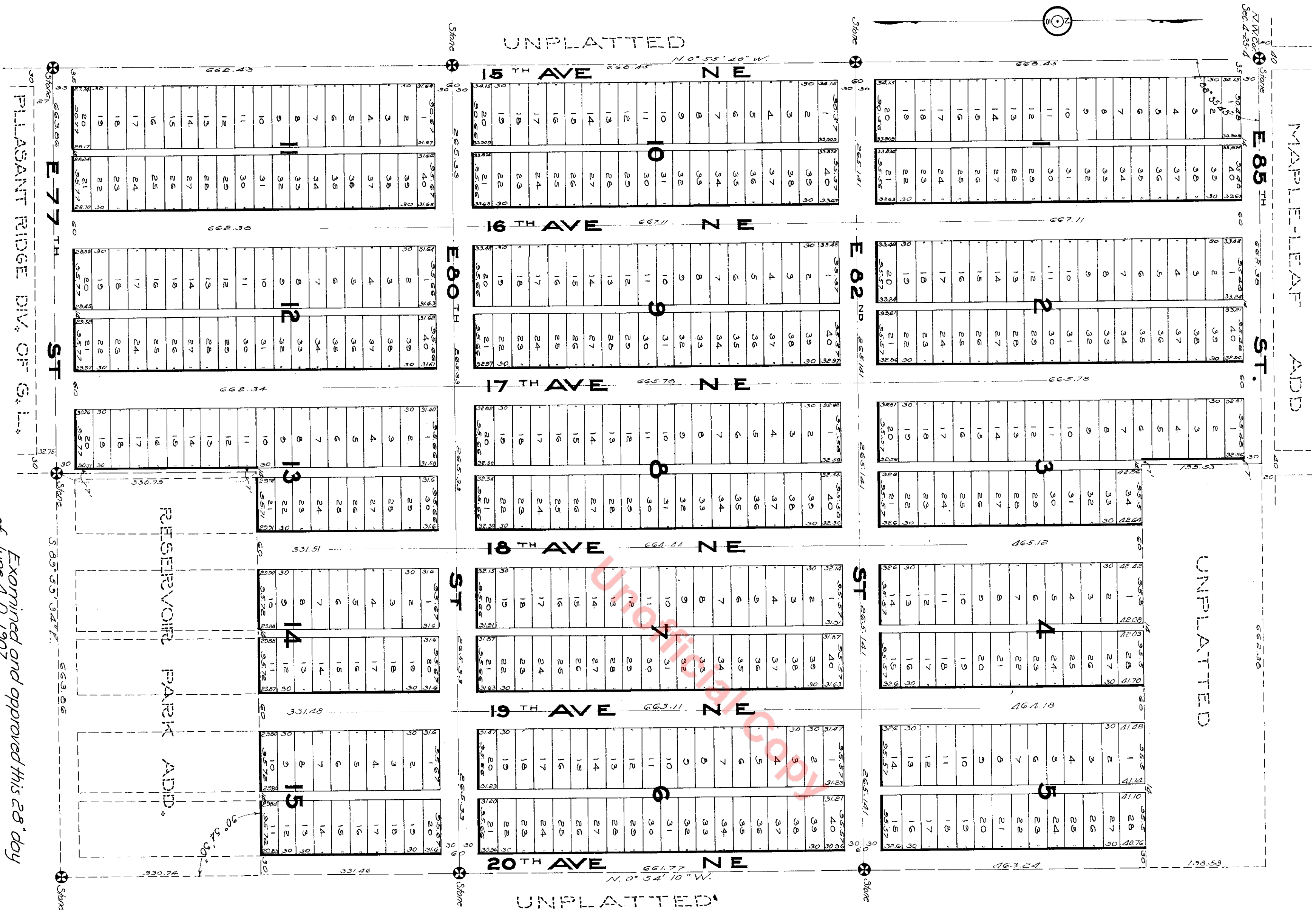
RESERVEVOIR ADDITION

DESCRIPTION

This plat embraces all of the N. $\frac{1}{2}$ of the N.W. $\frac{1}{4}$ and the N.W. $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the N.W. $\frac{1}{2}$ and the N.E. $\frac{1}{2}$ of the S.W. $\frac{1}{4}$ of the N.W. $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the Northernly 3 Acres of the NE $\frac{1}{4}$ of the N.W. $\frac{1}{2}$ of the N.W. $\frac{1}{2}$ all in Section 4, Tp. 25 N., R. 4 E., W. 1.

All distances are as shown on this plat in feet.

Bearings refer to City Standard Meridian.
