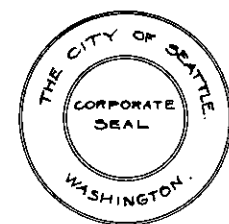

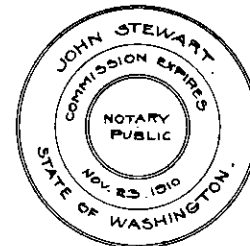

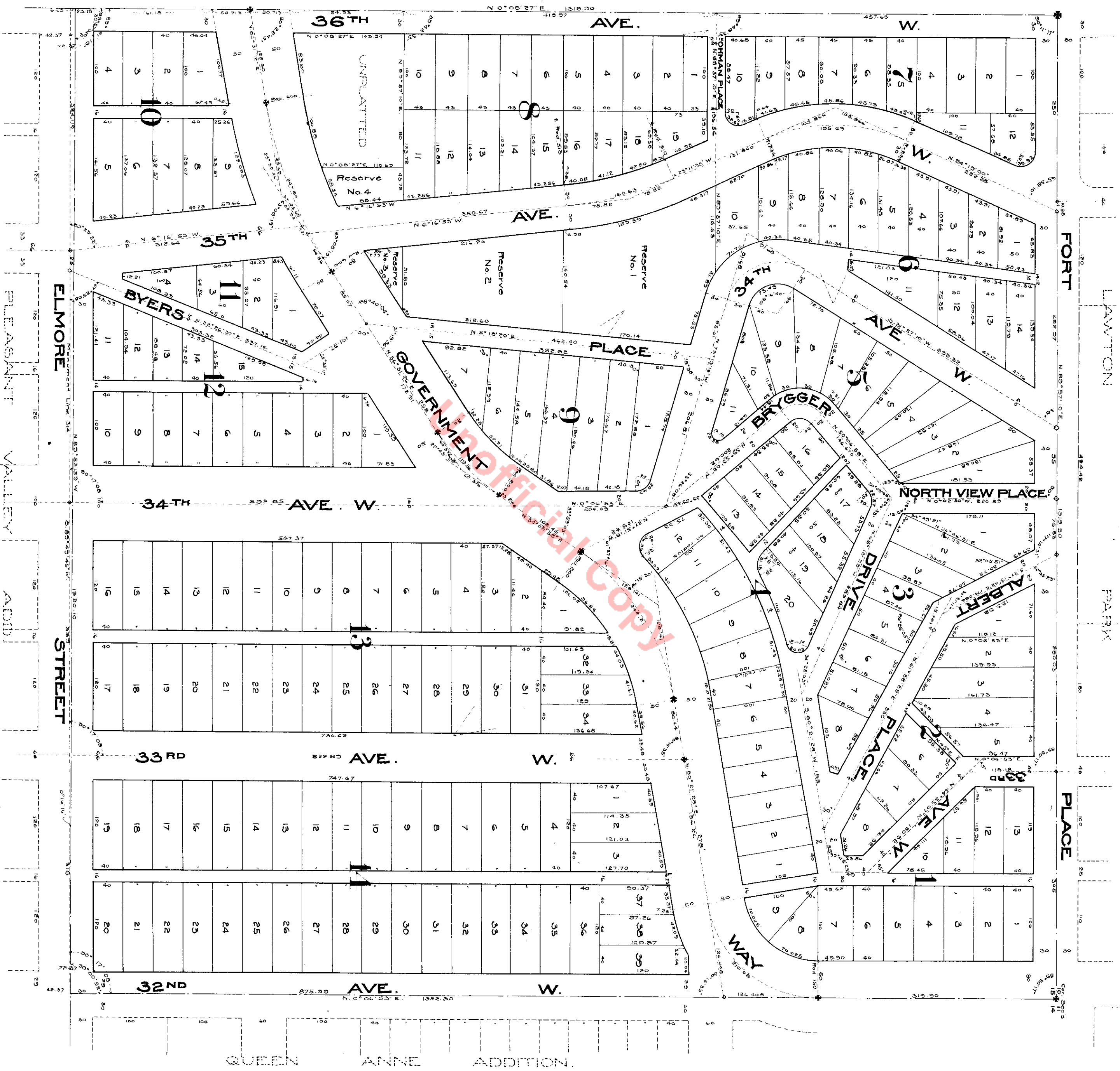

DESCRIPTION.

This plat of Lawton Heights, an Addition to the City of Seattle, comprises all of the N.E. 1/4 of the N.E. 1/4 of Section 15, T. 25 N., R. 3 E., W. 1 M., excepting the following described tract of land: Beginning at a point which is 441.28 feet N. 0° 08' 27" E. of and 30 feet N. 83° 57' 10" E. of the S.W. Corner of said N.E. 1/4 of N.E. 1/4, thence N. 83° 57' 10" E. 180 feet, thence S. 0° 08' 27" W. 110.63 feet to the north margin of Government Way, thence westerly along the north margin of said Government Way 184.68 feet, thence N. 0° 08' 27" E. 149.34 feet to the place of beginning. All dimensions and angles are as shown on the plat.
