All distances are as shown on this plat in feet.

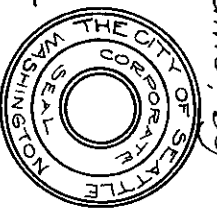

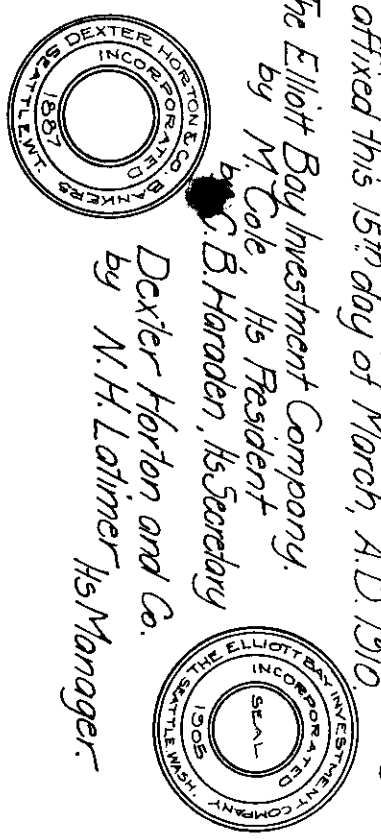


DEDICATION
