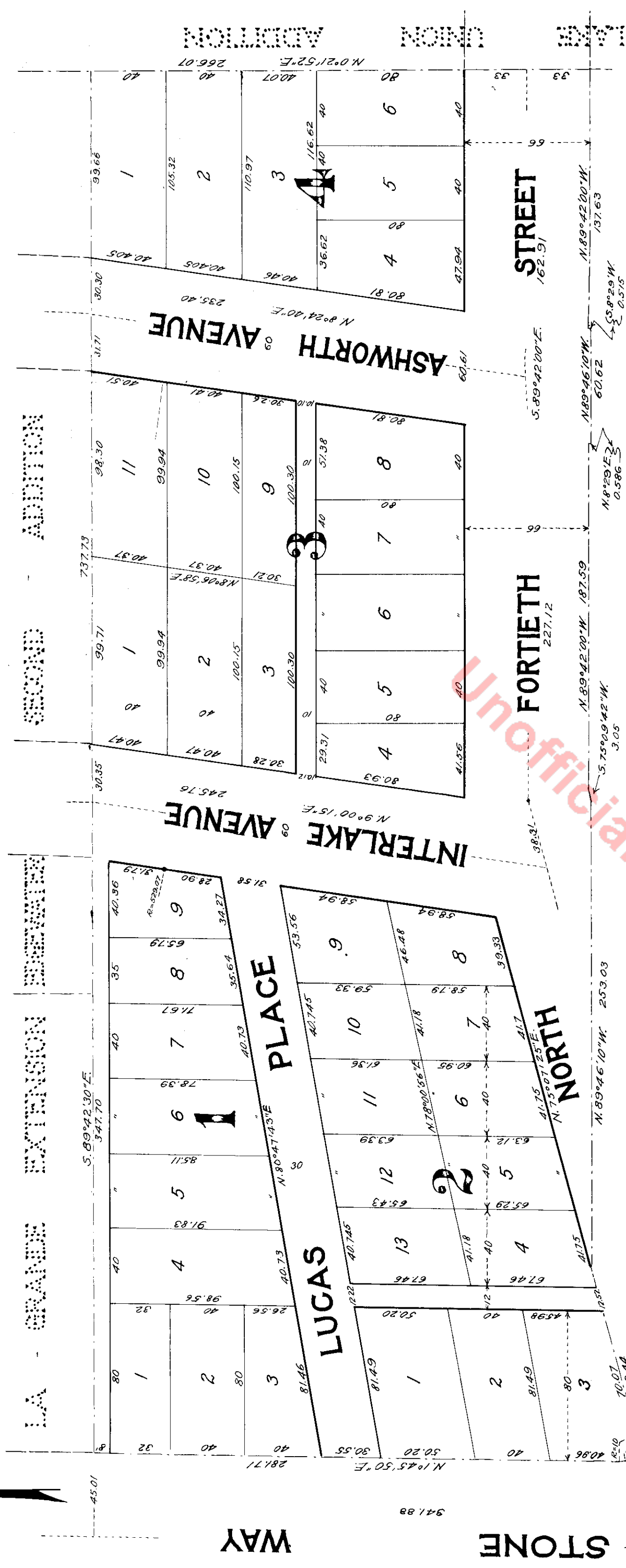


LUCAS ADDITION TO THE CITY OF SEATTLE

DESCRIPTION

This plat of "Lucas Addition to the City of Seattle" covers a tract of land described as follows, to wit: beginning at a point 12 1/100 chains north of the southeast corner of the southwest quarter of the northeast quarter (S. W. 1/4 of N. E. 1/4) of Section Eighteen (18), Township Twenty-five (25) North, Range Four (4) East of the Willapa Meridian, said point being the northeast corner of the tract of land heretofore deeded to W. M. Lucas Building Company and recorded in Volume 617 of Deeds, page 221, Records of King County, thence South 0° 21' 52" West along the east boundary line of said tract 266 7/100 feet, to the south boundary line of North Fortieth Street; thence along said south boundary line produced westward, north 89° 42' 00" west 13 7/100 feet; thence south 8° 29' 00" west 0° 57' 000 feet; thence north 89° 46' 10" west 60 67/100 feet; thence north 87° 59' 000 feet; thence south 75° 09' 42" west 3 9/100 feet; thence north 89° 46' 10" west 253 09/100 feet; thence south 75° 07' 25" west 93 44/100 feet to a point of curve; thence curving to the right through an arc of 18 7/100 feet, radius ten (10) feet, to a point of tangency on the easterly marginal line of Stone Way; thence along said easterly marginal line north 1° 43' 50" east 281 7/100 feet to the north boundary line of the above described tract; thence along said line south 89° 42' 30" east 737 1/100 feet to the place of beginning.

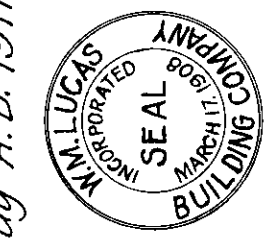
All dimensions are as shown on the face of the plat. All bearings are referred to the City Standard Meridian.

The initial point of this plat is the northeast corner of Lot one (1), Block four (4), which point is identical with the northeast corner of the original tract.

DEDICATION

Know all men by these presents, that the W. M. Lucas Building Company, a corporation duly organized and existing under the laws of the State of Washington, and having its principal place of business in the City of Seattle, in said State, and Harriet E. Taylor, Mortgagee, owners in fee simple of the land comprising Lucas Addition to the City of Seattle, do hereby declare this plat and dedicate to the use of the public forever all the streets, avenues, and alleys shown thereon.

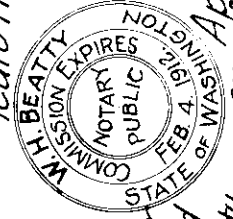
