## AN ADDITION TO THE CITY OF SEATTLE

### DESCRIPTION

This addition comprises that portion of Government Lot 2, Section 6, Township 25 North of Range 4 East of Willamette Meridian, described as follows: Beginning at the intersection of the easterly line of Woodland Park Avenue and the northerly line of West Green Lake Way as now laid out and established by the City of Seattle; running thence northerly along the east line of Woodland Park Avenue about 500 feet to the southerly line of the following described right of way: "A right of way 30 feet wide extending in a southwesterly direction across Lot 2, Section 6, Township 25 North of Range 4 East of Willamette Meridian from West Green Lake Way and Ashworth Avenue to Woodland Park Avenue and occupied by a single track, the center line of which is 10 feet north of the southerly line of the above described right of way; thence northeasterly along the southerly line of the said right of way to its intersection with the south line of North 77th Street as established by Ordinance 31199 of the City of Seattle; thence easterly along the south line of North 77th Street to its intersection with the westerly line of West Green Lake Way; thence southwesterly and westerly along the said westerly line of West Green Lake Way to the place of beginning.

### DEDICATION

Know all men by these presents that we, Geo. E. Morford and Gertrude Keen Morford, owners in fee simple of the tract of land platted in this "Winona Park an addition to the City of Seattle", do hereby declare this plat and dedicate to the use of the public forever all the streets, avenues, ways and alleys shown hereon, and the use thereof for any and all public purposes not inconsistent with the use thereof for public highway purposes, also the right to make all necessary slopes for cuts or fills upon the lots shown on this plat in the reasonable original grading of all streets, avenues, ways and alleys.

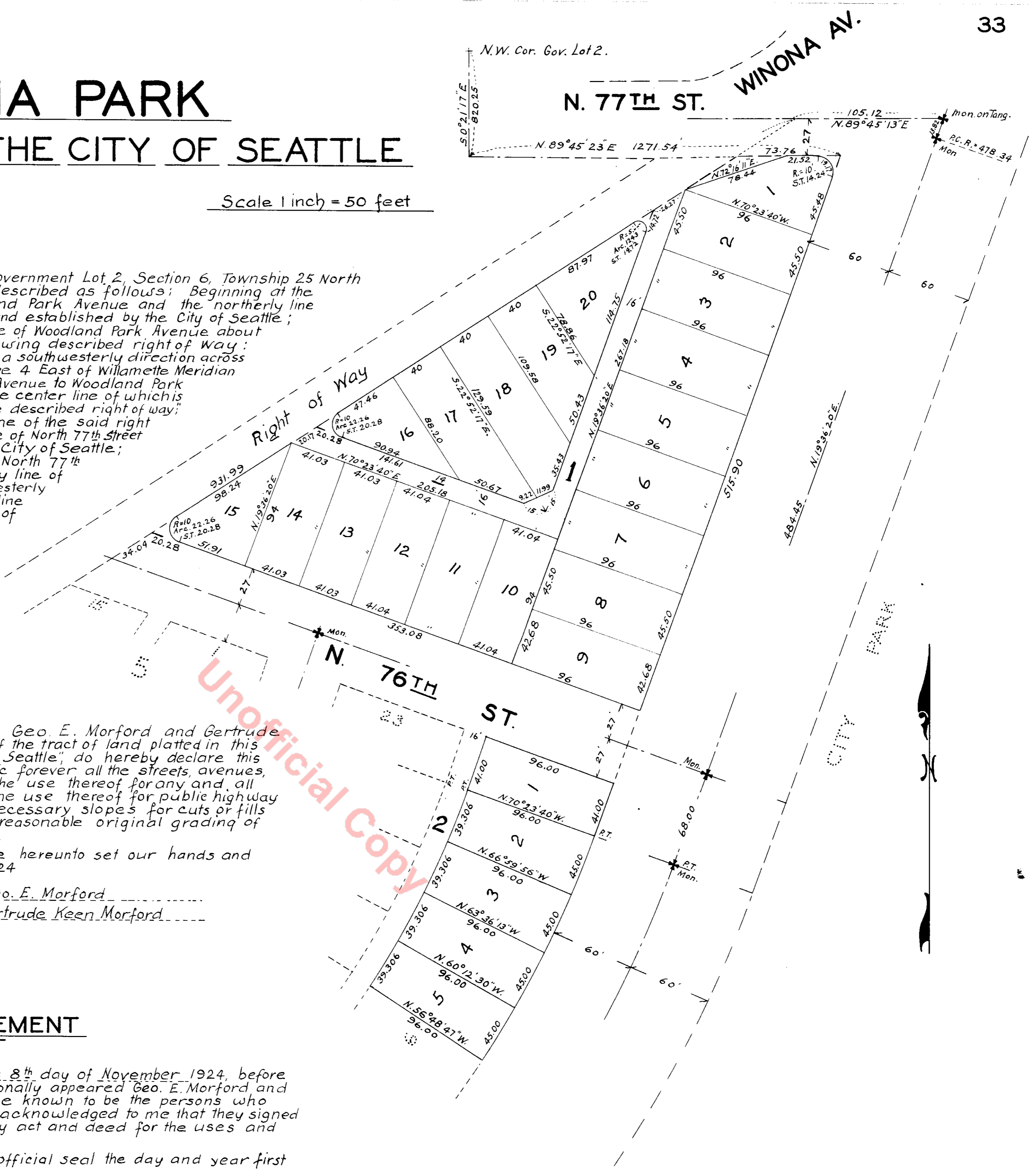
