## DESCRIPTION

This plat of O. W. Harris Addition embraces the following described tracts:

**Parcel A:**  
Commencing at a point 50 feet south of the northwest corner of southwest quarter of southwest quarter of Section Twenty-one (21), Township Twenty-five (25) North, Range Four (4) East W.M.; running thence easterly from said corner along a line parallel to north line of said southwest quarter of southwest quarter a distance of 75 feet; thence running southwesterly 123 feet, more or less, to a point on west line of said southwest quarter of southwest quarter 90 feet south of point of beginning; thence running north to point of beginning.

**Parcel B:**  
All that portion of northeast quarter of southeast quarter of southeast quarter of Section Twenty (20), Township Twenty-five (25) North, Range Four (4) East W.M., lying easterly of 15th Avenue North as extended and produced through northeast quarter of southeast quarter of southeast quarter of said section from East Garfield Street in the City of Seattle to intersection of East Howe Street of said city, except the north 12 feet thereof.

## DEDICATION

Know all men by these presents that we, Olin W. Harris and Lily G. Harris, his wife, owners of a portion of the land hereby platted and Henry F. McClure and A.B. Swensson, president and Secretary respectively of H. Watson Improvement Company a corporation existing under the laws of the State of Washington, owner of the remainder of tract hereby platted, hereby declare this plat and dedicate to the use of the public forever all streets, avenues, boulevards and alleys or whatever public property there is shown on plat, and the use thereof for any and all public purposes not inconsistent with the use thereof for public highway purposes, also the right to make all necessary slopes for cuts or fills upon the lots, blocks and tracts shown upon this plat in the original, reasonable grading of all the streets, avenues, boulevards and alleys shown thereon.

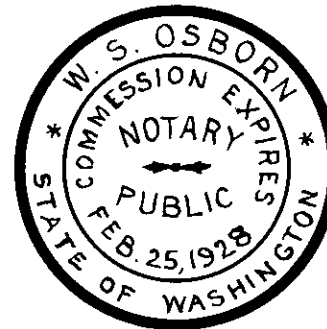
