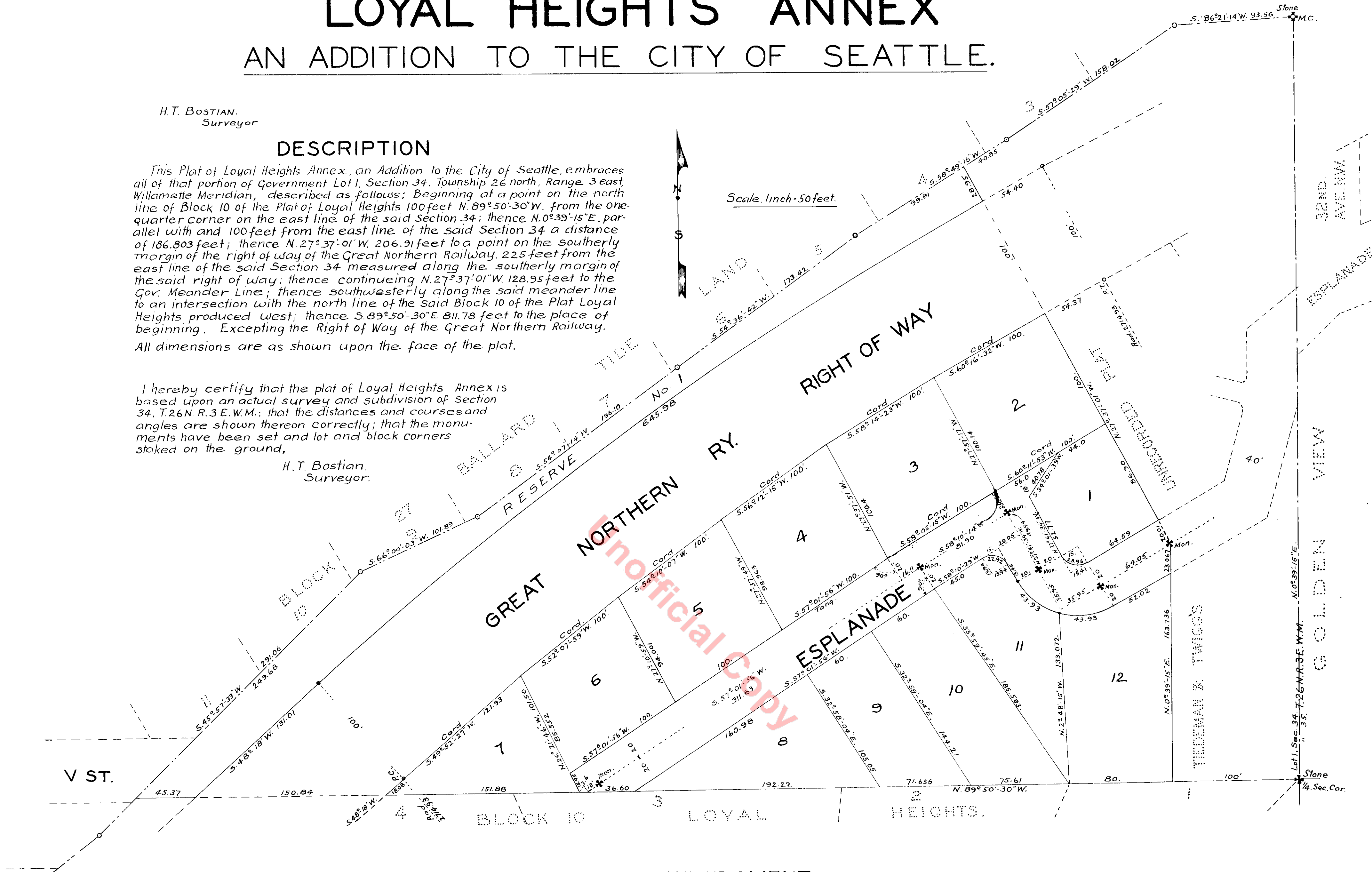

DESCRIPTION

This Plat of Loyal Heights Annex, an Addition to the City of Seattle, embraces all of that portion of Government Lot 1, Section 34, Township 26 north, Range 3 east, Willamette Meridian, described as follows: Beginning at a point on the north line of Block 10 of the Plat of Loyal Heights 100 feet N. 89° 50' 30" W. from the one-quarter corner on the east line of the said Section 34; thence N. 0° 39' 15" E. parallel with and 100 feet from the east line of the said Section 34 a distance of 186.803 feet; thence N. 27° 37' 01" W. 206.91 feet to a point on the southerly margin of the right of way of the Great Northern Railway. 225 feet from the east line of the said Section 34 measured along the southerly margin of the said right of way; thence continuing N. 27° 37' 01" W. 128.95 feet to the Gov. Meander Line; thence southwesterly along the said meander line to an intersection with the north line of the said Block 10 of the Plat Loyal Heights produced west; thence S. 89° 50' 30" E. 811.78 feet to the place of beginning. Excepting the Right of Way of the Great Northern Railway. All dimensions are as shown upon the face of the plat.

I hereby certify that the plat of Loyal Heights Annex is based upon an actual survey and subdivision of Section 34, T. 26 N. R. 3 E. W.M.; that the distances and courses and angles are shown thereon correctly; that the monuments have been set and lot and block corners staked on the ground,

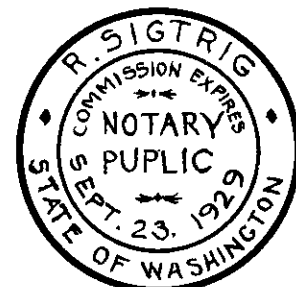
