

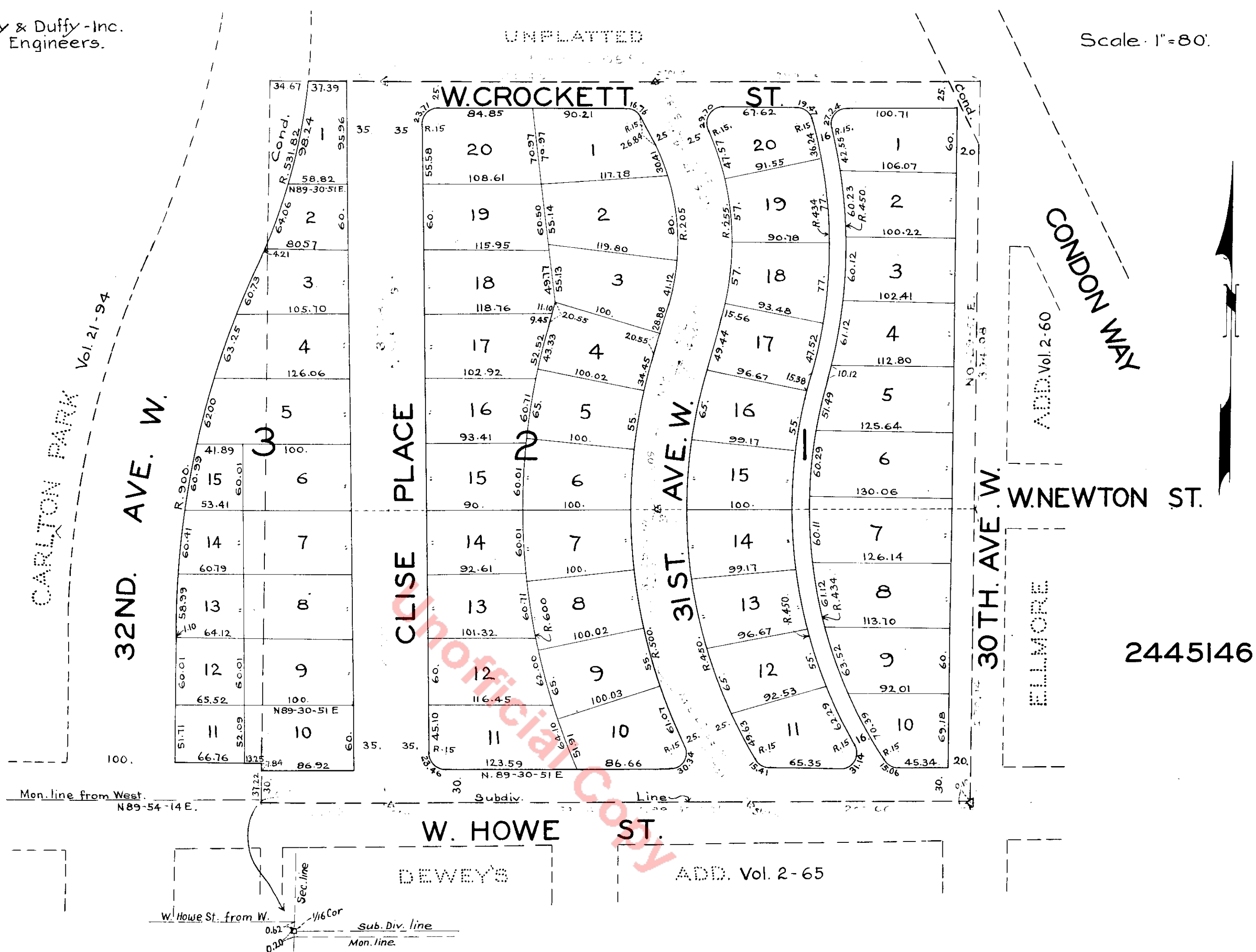
# MAGNOLIA VIEW ADD.

## DESCRIPTION

This plat of Magnolia View Addition embraces all of the SW 1/4 of the NW 1/4 of the SW 1/4 of Section 23-Twp. 25 N.R. 3E.W.M. and that portion of the SE 1/4 of the NE 1/4 of the SE 1/4 of Section 22-Twp. 25 N.R. 3E.W.M. lying East of 32nd Ave. West, and North of W. Howe St. excepting portions Cond.

## RESTRICTIONS.

The property embraced in this plat shall be used for private residence purposes only excepting the following described lots which may be used for business and commercial purposes: Lots One (1) to Five (5) inclusive and Lots Eleven (11) to Fifteen (15) inclusive all in block Three (3).

No building other than a single detached dwelling costing at least \$5000.00, with appurtenant private garage shall be built on any one lot in this plat, excepting the above mentioned business lot, and when built shall be used for residence purposes only. No old building shall be moved thereon.

No residence shall set closer than 20 feet from the street line upon which said building faces.

No property embraced in this plat shall be sold, conveyed, rented or leased to any person not of the white race.

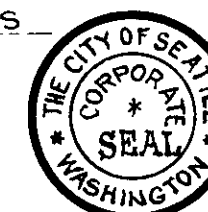

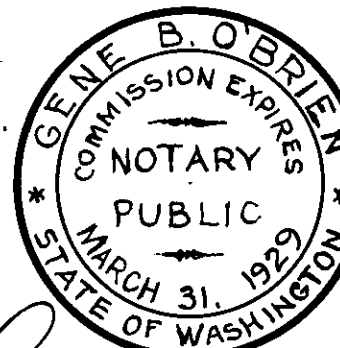
