THIS PLAT OF "ELFORD PARK" COVERS AND INCLUDES THAT PORTION OF GOV. LOT 2, SEC. 24, T. 26 N., R. 3 E. W. M. LYING EAST OF GREAT NORTHERN RAILROAD RIGHT OF WAY, EXCEPT THE EAST 30 FEET OF THE SOUTH 690.51 FEET THEREOF CONVEYED TO KING COUNTY FOR ROAD, BY DEED RECORDED UNDER AUDITOR'S FILE NO. 1419850, RECORDS OF KING COUNTY.

ALL COURSES AND DIMENSIONS ARE AS SHOWN ON THE FACE OF THIS PLAT. ALL MONUMENTS ARE OF CONCRETE, EXCEPT AS OTHERWISE DESIGNATED.

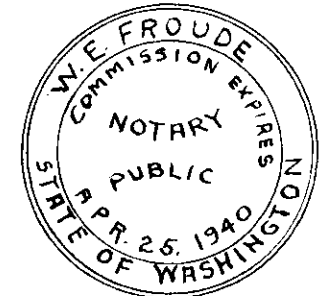

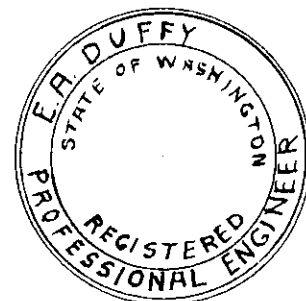
## RESTRICTIONS

NO LOT OR PORTION OF THIS PLAT, EXCEPT THOSE LOTS WHICH ARE HEREINAFTER RESTRICTED TO BUSINESS USE, SHALL BE DIVIDED AND SOLD OR RESOLD, OR OWNERSHIP CHANGED OR TRANSFERRED, WHEREBY THE OWNERSHIP OF ANY PORTION OF THIS PLAT SHALL BE LESS THAN THE AREA REQUIRED FOR THE USE DISTRICT STATED ON THIS PLAT; NAMELY, 6000 SQUARE FEET FOR RESIDENCE USE ACCORDING TO KING COUNTY RESOLUTION No. 6494 AS NOW IN FORCE OR AS AMENDED HEREAFTER, EXCEPT THAT SINGLE FAMILY DWELLINGS ONLY WILL BE PERMITTED. ALL LOTS IN THIS PLAT ARE RESTRICTED TO R-1 RESIDENCE DISTRICT USE EXCEPT AS RESTRICTIONS MAY BE HEREBY AMENDED.

NOT MORE THAN ONE SINGLE FAMILY DWELLING WITH THE NECESSARY ACCESSORY BUILDINGS REQUIRED FOR FAMILY USE SHALL BE CONSTRUCTED ON ANY TRACT IN THIS PLAT WITH THE EXCEPTION OF TRACT NUMBER ONE WHICH MAY BE SUBDIVIDED IN ACCORDANCE WITH ZONING RESOLUTION No. 6494, KING COUNTY, FOR MORE THAN ONE SINGLE FAMILY RESIDENCE. ALL BUILDINGS SHALL BE DESIGNED BY A MEMBER OF THE AMERICAN INSTITUTE OF ARCHITECTURE AND SHALL COST NOT LESS THAN \$5,000.00 TRACTS OR PARCELS OF LAND IN THIS PLAT SHALL BE USED OR OCCUPIED ONLY BY PERSONS OF THE WHITE OR CAUCASIAN RACE, EXCLUDING SEMITES AND NO OTHER PERSONS SHALL BE PERMITTED TO USE OR OCCUPY SAID TRACTS OR PARCELS, EXCEPT EMPLOYEES MAY OCCUPY THE PREMISES WHERE THEIR EMPLOYERS RESIDE.

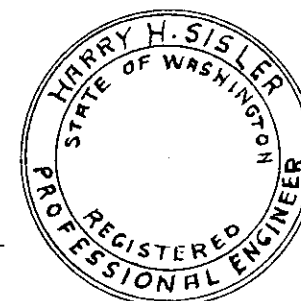

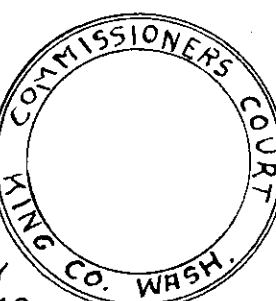
