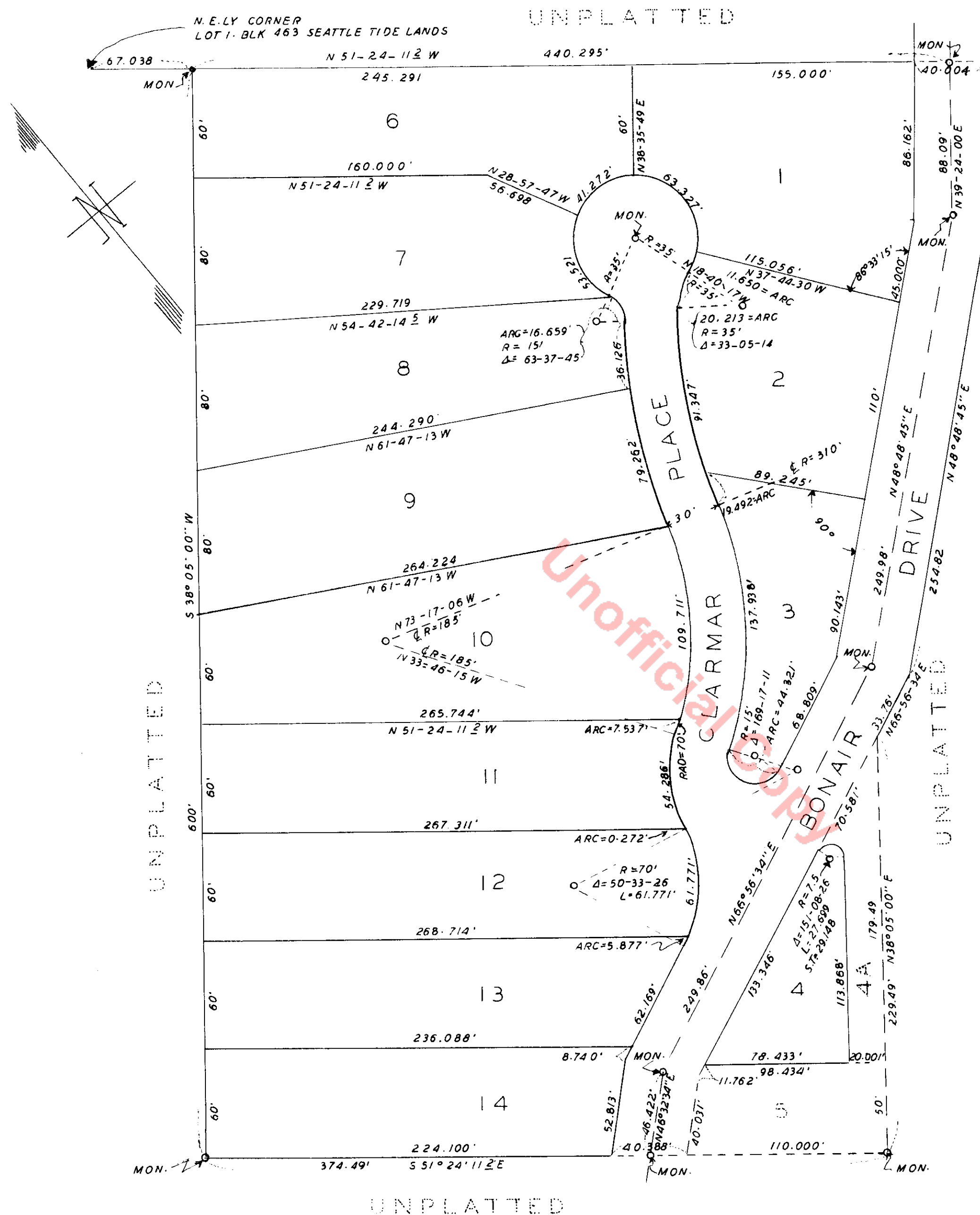


CLARMAR CRAGS

DESCRIPTION

THIS PLAT OF CLARMAR CRAGS SITUATED IN THE CITY OF SEATTLE, COUNTY OF KING, STATE OF WASHINGTON COMPRISES THAT PORTION OF SECTION 11, TOWNSHIP 24 NORTH, RANGE 3 E. W.M., DESCRIBED AS FOLLOWS:—

BEGINNING AT THE MOST WESTERLY CORNER OF BLOCK 24 OF REPLAT OF BLOCKS 8, 16, 17, 22, 23, AND 24 OF WEST SEATTLE PARK, AS PER PLAT RECORDED IN VOLUME 12 OF PLATS ON PAGE 49 RECORDS OF KING COUNTY; RUNNING THENCE NORTH $51^{\circ} 24' 11.2''$ WEST 54.286 FEET TO THE TRUE POINT OF BEGINNING OF THE TRACT HEREIN DESCRIBED; THENCE CONTINUING NORTH $51^{\circ} 24' 11.2''$ WEST 440.295 FEET; THENCE SOUTH $38^{\circ} 05' 00''$ WEST 600.00 FEET; THENCE SOUTH $51^{\circ} 24' 11.2''$ EAST 374.49 FEET; THENCE NORTH $38^{\circ} 05' 00''$ EAST 229.49 FEET; THENCE NORTH $66^{\circ} 56' 34''$ EAST 33.76 FEET; THENCE NORTH $48^{\circ} 48' 45''$ EAST 254.82 FEET; THENCE NORTH $39^{\circ} 24' 00''$ EAST 90.01 FEET TO THE TRUE POINT OF BEGINNING; EXCEPT TRACTS 4A AND 5 SHOWN THEREON; AND LESS EXISTING PUBLIC ROAD.

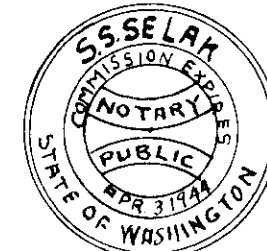

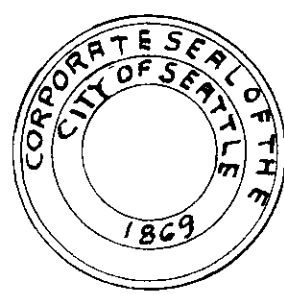
