

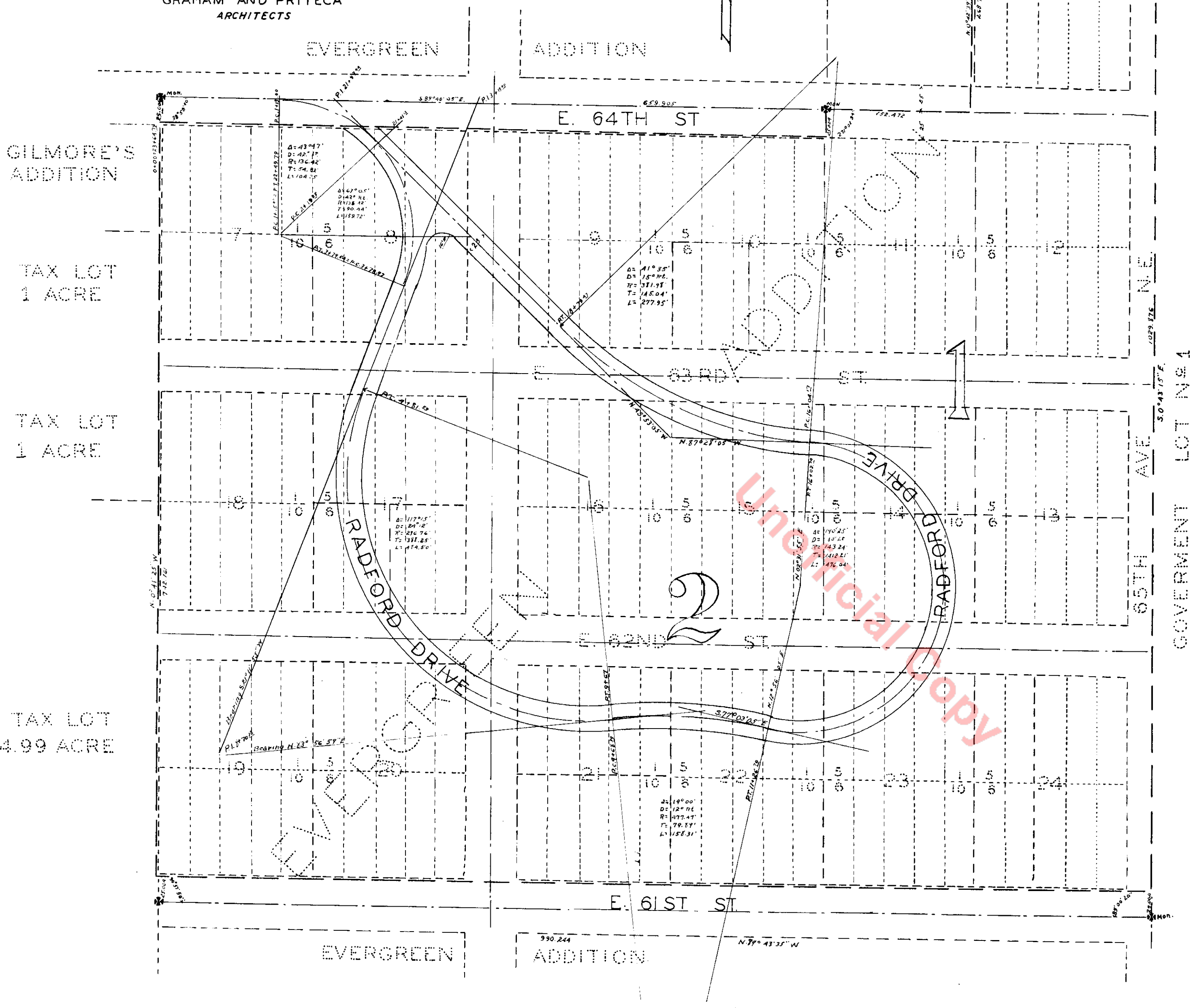
CORRECTION PLAT OF SAND POINT HOMES

— DEDICATION —

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS THE PLAT OF SAND POINT HOMES RECORDED IN VOLUME 37 OF PLATS, PAGE 46, RECORDS OF KING COUNTY, WASHINGTON, INCORRECTLY INCLUDED BLOCK 2 OF EVERGREEN ADDITION; AND

WHEREAS, BY REASON OF THIS FACT THERE IS SOME QUESTION CONCERNING THE VALIDITY OF ORDINANCE #71247 OF THE CITY COUNCIL OF THE CITY OF SEATTLE APPROVING SAID PLAT, AND IT IS DESIRABLE TO CORRECT THIS DEFECT BY FILING A NEW PLAT OF SAND POINT HOMES OMITTING SAID BLOCK 2, EVERGREEN ADDITION.

NOW, THEREFORE, THE HOUSING AUTHORITY OF THE CITY OF SEATTLE, A PUBLIC BODY CORPORATE AND POLITICAL, CREATED BY AND ORGANIZED PURSUANT TO THE HOUSING AUTHORITIES LAW OF THE STATE OF WASHINGTON, OWNER IN FEE SIMPLE OF THE LAND HEREBY REPLATED, HEREBY DECLARES THIS REPLAT AND DEDICATES TO THE PUBLIC FOREVER RADFORD DRIVE, AS SHOWN HEREON, TOGETHER WITH THE RIGHT TO ENTER UPON THE REAL PROPERTY ABUTTING UPON SAID DRIVE FOR THE ERECTION, OPERATION AND MAINTENANCE OF STREET AND TRAFFIC SIGNS NECESSARY FOR THE GUIDANCE AND SAFETY OF THE PUBLIC; ALSO THE RIGHT TO ENTER UPON SAID REAL PROPERTY FOR THE OPERATION AND USE FOR FIRE PROTECTION AND STREET WASHING OF FIRE HYDRANTS OWNED AND MAINTAINED BY THE PLATTER.

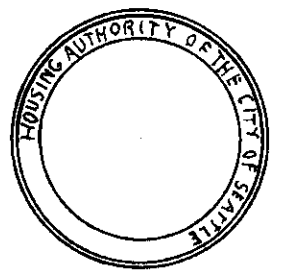
THE PLATTER FURTHER ASSUMES THE CARE AND MAINTENANCE OF ALL DRAINAGE FROM SAID RADFORD DRIVE AND PLEDGES ITSELF TO SAVE THE CITY HARMLESS FROM ALL DAMAGES CAUSED BY OVERFLOW OF WATER FROM SAID DRIVE.

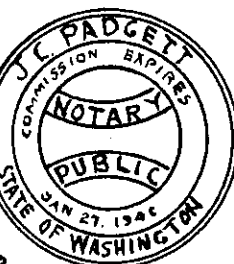
