DESCRIPTION

THIS PLAT OF WM CULLITON ADDITION COMPRISES THE FOLLOWING DESCRIBED TRACT OF LAND: THE EAST 445.50 FEET OF THE SOUTH 742.50 FEET OF THE NORTH 990.00 FEET OF THE NORTHEAST QUARTER (N.E. 1/4) OF THE SOUTHWEST QUARTER (S.W. 1/4) OF SECTION TWENTY-ONE (21), TOWNSHIP TWENTY FOUR (24) NORTH, RANGE FOUR (4) EAST, W.M., LYING WESTERLY OF BEACON AVE. EXCEPT ALSO THE SOUTH FORTY (40) FEET OF THE NORTH 287.50 FEET OF THE EAST 305.50 FEET OF THE NORTHEAST QUARTER (N.E. 1/4) OF THE SOUTHWEST QUARTER (S.W. 1/4) OF SECTION 21-TWP. 24 N. R. 4 E. W.M.; EXCEPT ALSO THAT PORTION OF THE N.E. 1/4 OF THE S.W. 1/4 OF SECTION 21, TWP. 24 N. R. 4 E. W.M. DESCRIBED AS FOLLOWS: BEGINNING ON THE WEST LINE OF BEACON AVENUE AT A POINT WHICH IS S. 11° 41' 17" E. 295.13 FEET FROM ITS INTERSECTION WITH THE NORTH LINE OF SAID SUBDIVISION; THENCE N 87° 54' 54" W 53.89 FEET; THENCE S 7° 36' 09" E. 116.43 FEET; THENCE S 89° 29' 19" E 62.03 FEET; THENCE N 11° 41' 17" W 116.40 FEET TO POINT OF BEGINNING; EXCEPT ALSO THE FOLLOWING DESCRIBED TRACT OF LAND: THAT PORTION OF THE N.E. 1/4 OF THE S.W. 1/4 OF SECTION 21, TWP. 24 N. R. 4 E. W.M., DESCRIBED AS FOLLOWS: BEGINNING ON THE WEST LINE OF BEACON AVENUE AT A POINT WHICH IS S. 11° 41' 17" E. 452.70 FEET FROM ITS INTERSECTION WITH THE NORTH LINE OF SAID SUBDIVISION, BEING THE TRUE POINT OF BEGINNING; THENCE N 89° 29' 19" W 69.84 FEET; S. 2° 47' 34" E 108.69 FEET; THENCE S 89° 29' 19" E 86.95 FEET; THENCE N 11° 41' 17" W 111.01 FEET TO THE POINT OF BEGINNING.
