DESCRIPTION

This plat of "VISTA MOUNTAIN" is a replat of a portion of The Uplands, an Addition to the City of Seattle, as said plat is recorded in volume 28 of plats, page 42, records of King County, Washington, and embraces the following: Lots Twenty-four (24) to Thirty-two (32), both inclusive, in Block Fourteen (14); All of Blocks Fifteen (15), Nineteen (19), Twenty-one (21) and Twenty-two (22); Block Eighteen (18) excepting Lot Twelve (12) thereof; Block Twenty (20) excepting Lots One (1) to Eight (8), both inclusive, together with streets, service roads and park within the above described blocks, all as shown in dotted lines hereon.

All courses and dimensions are as shown hereon.

DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that we, Charles C. Shedd and Edith W. Shedd, his wife, owners in fee simple of the land hereby platted, hereby declare this plat and dedicate to the use of the public forever the streets, avenue, place and terrace shown hereon and the use thereof for any and all public purposes not inconsistent with the use thereof for public highway purposes, also the right to make all necessary slopes for cuts or fills upon the lots and blocks shown hereon in the reasonable original grading of the streets, avenue, place and terrace shown hereon.

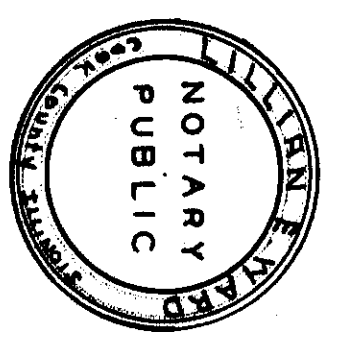

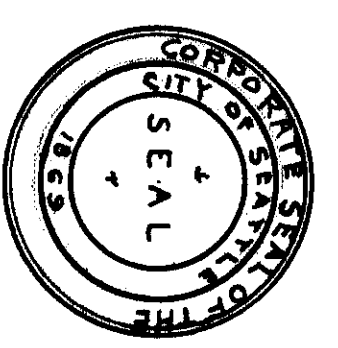
