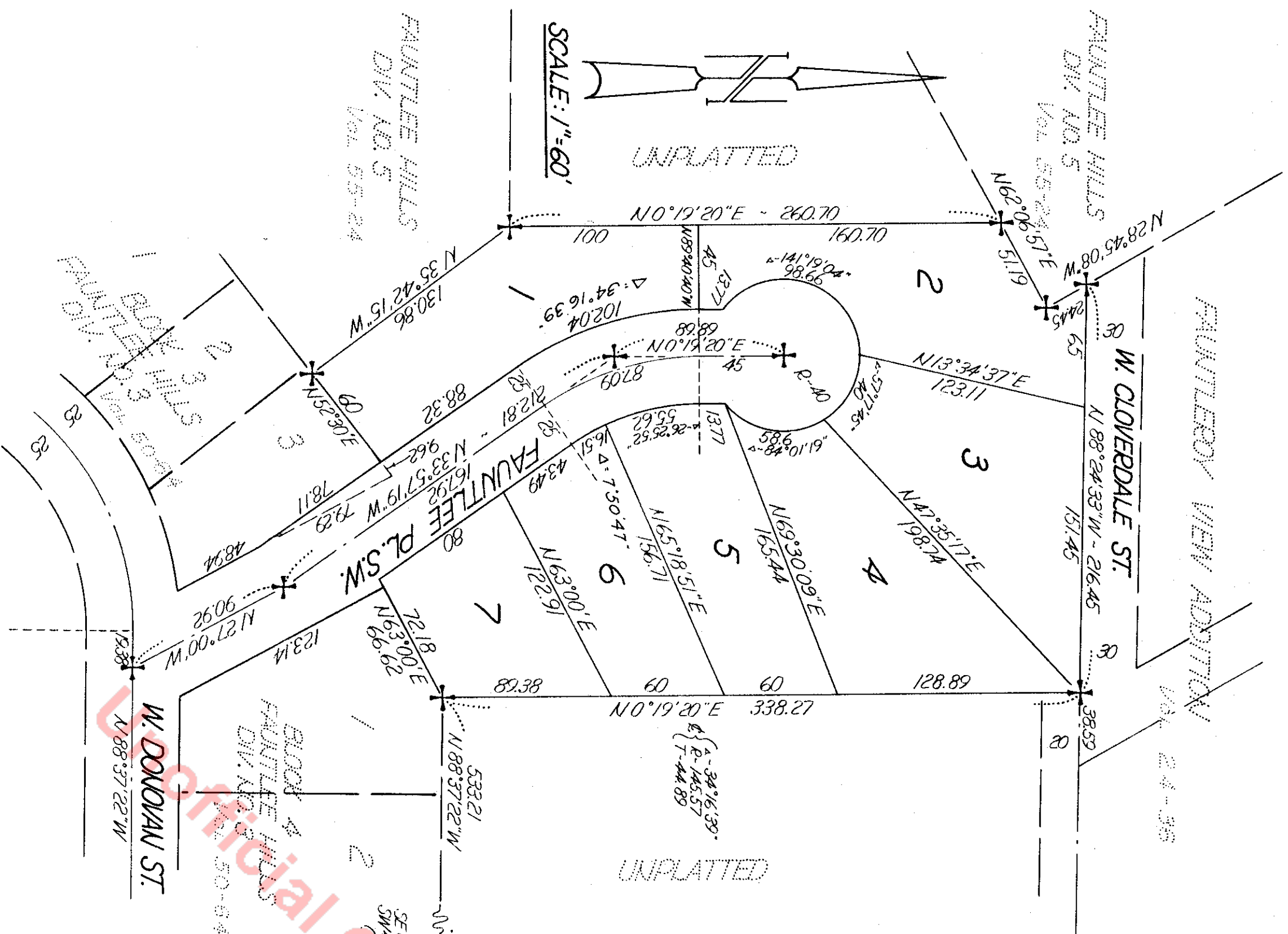


ROBERT E. THOMAS ADDITION

DESCRIPTION

All that portion of the South one-half of the Southwest one-quarter of the Northeast one-quarter of Section 35, T24N, R3E W.M., in King County, Washington, described as: "Beginning at a point on the south line of the North one-half of the above said subdivision, N 88° 37' 22" W, along the south line, 338.27 ft.; thence N 88° 24' 33" W, 216.45 ft.; thence N 0° 19' 20" E, 338.27 ft.; thence N 51° 19' 20" W, 216.45 ft.; thence S 28° 45' 08" E, 244.5 ft.; thence S 62° 06' 57" W, 51.19 ft.; thence S 0° 19' 20" W, 260.70 ft.; thence S 35° 42' 15" E, 130.86 ft.; thence N 52° 30' E, 69.62 ft.; thence S 27° 00' E, 30.61 ft.; thence N 63° 00' E, 116.62 ft. to the point of beginning. Also that portion of Lot 3, Block 3, Faultlee Hills Division No. 3 Addition, as per plat recorded in Volume 50 of PLATS, page 64, in King County, Washington, described as: "Beginning at the west NW corner thereof; thence S 27° 00' E, along the Easterly line of said Lot 3, 79.29 ft.; thence N 33° 57' 15" W, 781.1 ft. to a point on the Northerly line of said Lot 3; thence N 52° 30' E, along the Northerly line of said Lot 3, and the point of beginning."

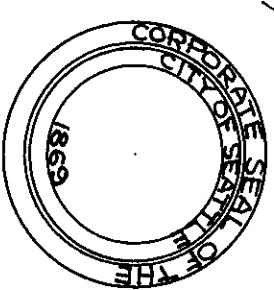

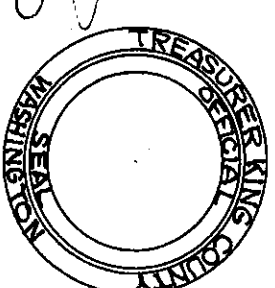

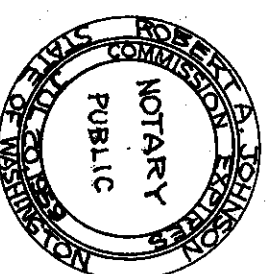
