DESCRIPTION

Portion of Samuel A. Maple Donation Land Claim No.49 in Section 28, Township 24 North, Range 4 East, W.M. in King County, Washington described as follows:
Beginning at the point of intersection of the south margin of South Willow Street with the east line of said Donation Land Claim; thence South 0°14'16" West along said east line, 100 feet to the true point of beginning; thence North 89°39'21" West 313.5 feet; thence South 0°14'16" West, 233.80 feet to the northeasterly margin of Swift Avenue South; thence South-easterly along said northeasterly margin, 422.88 feet to the east line of said Donation Land Claim; thence North 0°14'16" East, 507.28 feet to the true point of beginning.

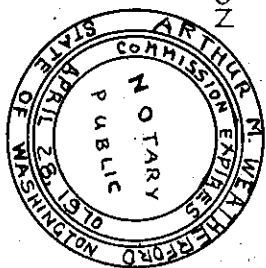

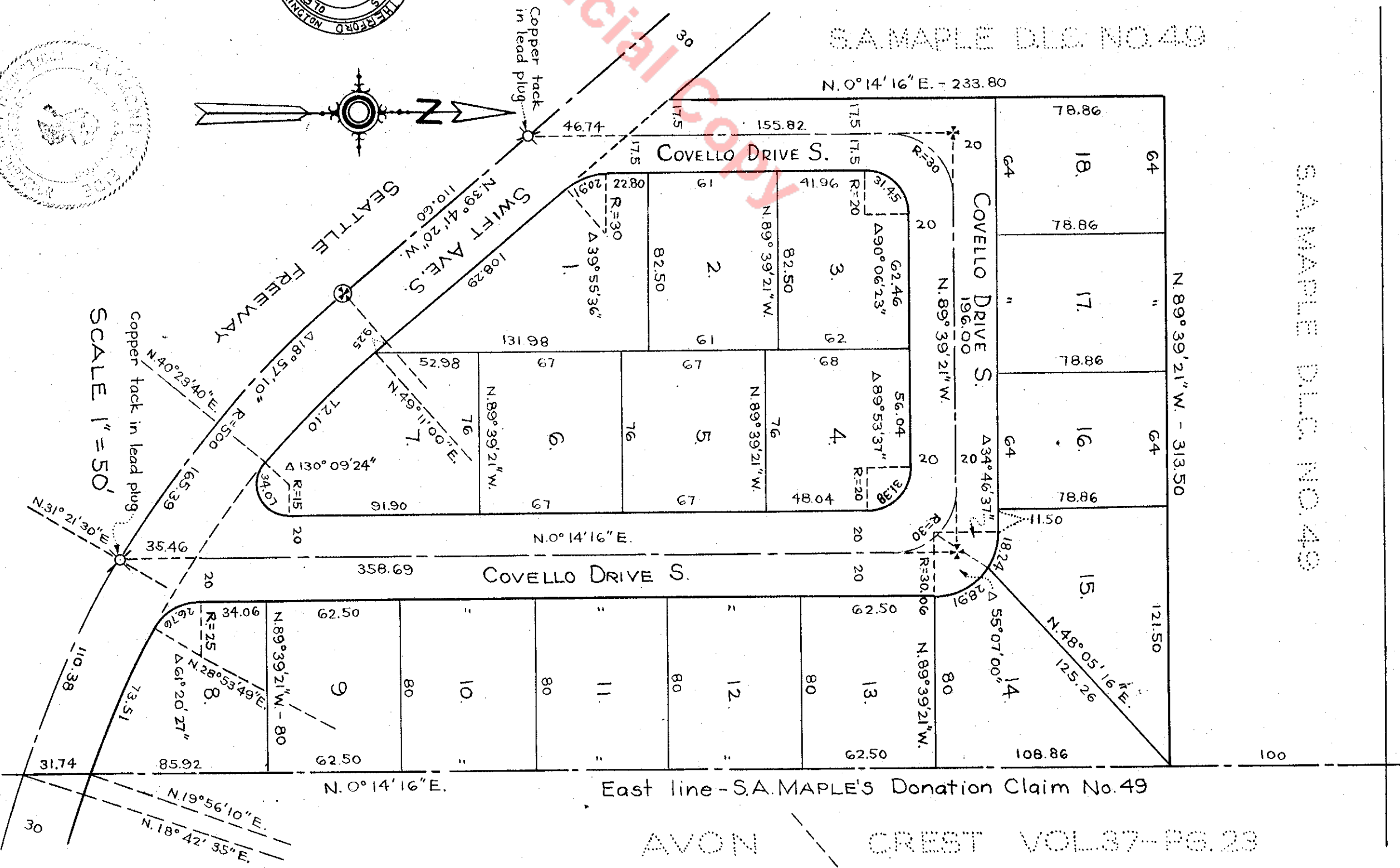

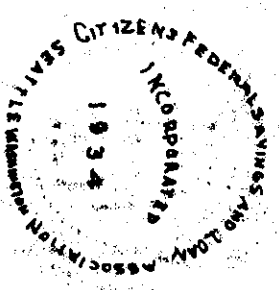
DEDICATION
